ORDER

District Institute of Education and Training, Chhibramau, Kannauj-209721, Uttar Pradesh had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for an additional intake of 100 seats in BTC course of Two Year duration from the academic session 2004-2005 in terms of section 15(1) of NCTE Act, 1993.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the inputs received from the visiting team, the Committee has noted the following:

- (a) The institution has the land for setting up the teacher education institution.
- (b) The institution has the building for conducting the course on the above-mentioned land.
- (c) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to District Institute of Education and Training, Chhibramau, Kannauj-209721, Uttar Pradesh for an additional intake of 100 (One Hundred) seats in BTC course of Two year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.

Cont.2...

- (a) Appointment of the Principal and the faculty members duly qualified and staff as per the norms of NCTE/State Govt./ UGC is to be completed before the commencement of the session.
  - (b) The countersigned statement of all faculty members from the Director, SCERT, UP, should be submitted before the commencement of the academic session 2004-2005.
  - (c) Instructional Facilities in the Psychology lab be created for an additional intake of seats.
  - (d) Instructional Facilities in the Education Technology be created for an additional intake of seats.
  - (e) The institution shall adhere to all the other Regulations and Guidelines as framed by NCTE from time to time.
  - (f) Non-compliance of above conditions as mentioned vide this Order of Recognition shall invite action under Section 17(1) of NCTE Act, 1993.
4. The Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / State Govt. / Affiliating body.
  5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
  6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
  7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and/or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
