WITHDRAWAL ORDER

19 JUL 2020

WHEREAS, the recognition was granted by the Northern Regional Committee to Smt. Prem Lata Maya Devi Agarwal Girls Degree College, Post Office – Raya, District – Mathura, State – Uttar Pradesh, Pin Code - 281204 vide Order No. NRC/NCTE/F-3/UP-1253/8928-8937 dated 12.08.2005 for B.Ed. course of one year duration with an annual intake of 100 seats. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/UP-1253/2015/112345-51 dated 06.06.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 students each was issued to the institution with certain conditions.

2. AND, WHEREAS, the institution has not submitted documents/reply in compliance of the revised recognition order.

3. AND, WHEREAS, the matter was placed the Northern Regional Committee in its 281st Meeting held from 20th to 21st February, 2018. The Committee decided to issue show cause notice to all such institutions which have not submitted compliance of the revised recognition order.

Accordingly, Show Cause Notice dated 28.03.2018 was issued to the institution.

2. AND, WHEREAS, Dr. B. R. A. University, Agra, stated in their letter No. 8109/2019 dated 19.01.2019 that एन०सी०टी०ई० द्वारा बी०ए० पाठ्यक्रम संचालन हेतु विनियमन 2014 लागू किया गया है एवं विनियमन के प्रावधान के अनुसार आपके महाविद्यालय में बी०ए० पाठ्यक्रम में छात्रों के पठन पठन हेतु एक यूनिट (100 छात्रों) पर 0803 (विशिष्ट विषय शिक्षक –फाईन आर्ट, संगीत एवं शारीरिक शिक्षा) 11 तथा दो यूनिट (100 छात्रों) पर 16 शिक्षकों का अनुमोदन विश्वविद्यालय से प्राप्त करना चाहिये था, किन्तु विनियमन लागू होने के 04 वर्ष बाद भी उक्त महाविद्यालय द्वारा न तो कोर-फैकल्टी और नही विशिष्ट विषयों यथा 7 फाईन आर्ट, संगीत, शारीरिक शिक्षा का शिक्षक अनुमोदित कराये गये है जो कि विनियमन 2014 के अनुसार नियम विरुद्ध है साथ ही माननीय कुलपति जी के दिनांक 16.11.2017 के आदेशानुसार महाविद्यालय में पूर्व से कार्यरत शिक्षकों का अनुमोदन 05 वर्ष पूर्ण होने पर प्रशासनिक संख्या 2218/सत्तर-2-2011-16(409)/2010 दिनांक 23.08.2011 के अनुपालन में विश्वविद्यालय से पूर्व अनुमोदन निरस्त कर दिया गया है। इस संबंध में सभी महाविद्यालयों की लॉगिन पर विश्वविद्यालय के पत्रांक संख्या 4213/2017 दिनांक 17.11.2017 के द्वारा सूचना अपलोड की गयी थी तथा विश्वविद्यालय द्वारा पुनः एक पत्र संख्या 4361/2017 दिनांक 15.12.2017 के द्वारा भी आपके महाविद्यालय में संचालित स्थायी बी०ए० पाठ्यक्रम से संबंधित विभिन्न वॉछित सूचनायें उपलब्ध कराने हेतु महाविद्यालय की लॉगिन पर सूचना अपलोड करायी गयी थी किन्तु आपके द्वारा उपरोक्त पत्रों के सापेक्ष में किसी तरह की सूचना आज तक उपलब्ध नहीं करायी गयी, जो कि संवैधानिक शर्तों का उल्लंघन है। ऐसा प्रतीत होता है कि महाविद्यालय प्रबन्धन/प्रशासन उपरोक्त पाठ्यक्रम को संचालित करने में रुचि नहीं ले रहा है।

3. **AND, WHEREAS**, as per decision of the NRC in its 301st Meeting held on 09th to 11th May, 2019, a show cause notice u/s 17 was issued to the institution on 19.06.2019 seeking their comments on the complaint raised by the affiliating university.


4. **AND, WHEREAS**, the institution has submitted reply in NRC office on 23.07.2019. The matter was considered by the NRC in its 311th Meeting held from 16th to 17th January, 2020 and the Committee decided as under: -

- As per SOP, two SCNs u/s 17 have already been issued. Therefore, the recognition of the institution may be withdrawn as enough opportunities have been given to the institution.

Hence, NRC decided to withdraw the recognition under Section 17 of the NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal. A detailed withdrawal order be issued to the college.

5. **NOW, THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Northern Regional Committee hereby withdraws recognition of **Smt. Prem Lata Maya Devi Agarwal Girls Degree College, Post Office – Raya, District – Mathura, State – Uttar Pradesh, Pin Code - 281204** granted for B.Ed. course for an intake of 100 seats on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.
