CONTINUATION ORDER

1 4 SEP 2023

WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Malini Valley College of Education, Kotdwara Pauri Garhwal, State- Uttarakhand for conducting B.Ed. Course of one-year duration with an annual intake of 100 (One Hundred) vide Order No. F.NRC/NCTE/F-7/9913-21 dated 02.12.2006 and Revised Recognition Order issued to the institution vide order No. NRC/NCTE/UR-58/2015/101888-893 dated 21.05.2015 for B.Ed. programme of two years' duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-2016.

2. AND WHEREAS, Public Notice was issued on 30th March, 2021 regarding compliance of the Revise Recognition Order. The institution has submitted compliance of Revise Recognition Order received in NRC office on 28.05.2021. The matter was considered by NRC in its 407th Meeting held on 10th August, 2023 and committee decided that Second show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 07 days from the date of issue of show cause notice on the following grounds:

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The recognition was granted to the institution for B.Ed. course of one-year duration with an annual intake of 100 students from the academic session 2006-2007 vide order dated 02/12/2006 and revised recognition order for B.Ed. two years duration with an intake of two basic units of 50 each vide order dated 21/05/2015.

The matter was considered in NRC in its 333rd meeting and the committee decided that in case the institution(s) has already submitted the compliance, it may submit the copy of the same along with the relevant enclosures/documents, however, the staff list to be submitted by the institution should be of the staff presently working in the institution as per norms.

Accordingly, public notice dated 30/03/2021 uploaded in NCTE, NRC website. The institution has submitted reply of public notice vide letter dated 19/04/2021. The matter considered in NRC and the Committee observed the following:

- The institution is required to submit proof / evidence to prove that it is a Multi-disciplinary institution as per the NCTE Regulations, 2014.
- The institution is required to submit Certified registered land documents issued by the Registering Authority
- The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot-No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
- The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.

• The institution is required to submit Certified copy of site plan with demarcated land area for running different courses.

• The institution is required to submit Building safety certificate from the Competent Government

• The institution is required to submit Fire safety certificate issued by the Competent Government Authority.

• The institution is required to submit Certificate to the effect that the building is differently abled

friendly from the Competent Government Authority.

• The institution is required to submit Building Completion Certificate signed by the Competent Government Authority.

• The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on nonjudicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.

• The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.

• The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.

• The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.

 The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.

• Status of NAAC.

Hence, the NRC decided that Final Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 7 days from the date of issue of Show Cause Notice."

Accordingly, Second Show Cause Notice U/S 17 was issued to the institution on 24.08.2023.

AND WHEREAS, the institution has submitted reply dated 17.08.2023 of the Second Show Cause Notice u/s 17 received in NRC office on 23.08.2023. The matter was placed before NRC in its 410th meeting held on 04th & 5th September, 2023 Blended Mode and the committee decided as under:

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

As per decision of NRC in its 407th meeting final SCN was issued to the institution on 24/08/2023. The institution has submitted reply of final SCN on behalf of Minutes uploaded in Website vide letter dated 23/08/2023. The matter considered in NRC and the committee observed the following:

• The institution has submitted all required documents against the final SCN.

In view of the above, the NRC decided that recognition continuation order for B.Ed. course of two years duration with an annual intake 100 students (two basic units) of 50 students each to the institution."

- 4. NOW THEREFORE, this order is issued permitting the institution i.e. Malini Valley College of Education, Kotdwara Pauri Garhwal, State- Uttarakhand for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 100 (two basic units) of 50 students each subject to fulfilment of the following conditions:-
 - (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
 - (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 5. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 6. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 7. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-
 - (a) Sanctioned programme(s) along with annual intake in the institution.
 - (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last, quarter:
 - (d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - (e) Fee charged from students;
 - (f) Available infrastructural facilities;
 - (g) Facilities added during the last quarter;
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information if it so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 9. The institution shall make available the list of students admitted on its official website.
- 10. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
