CONTINUATION ORDER

04 OCT 2023

WHEREAS, the recognition under section 14(15)(3)(a) of NCTE Act, 1993 was granted to the institution namely, **Abhinav Sewa Sansthan Mahavidyalaya, 81, Q Rajeev Puram, (Marana Pratap Nagar), Kanpur - 208091, Uttar Pradesh** for conducting **B.Ed.** Course of one year duration with an annual intake of 100 (One Hundred) from the academic session 2003-2004 vide order No. NRC/NCTE/F-3/UP-771/2003/2563-2571 dated 08.07.2003 and **B.Ed. additional intake** of one year duration with an annual intake of 100 (One Hundred) (Existing 100 + Additional 100 = 200) vide order No. NRC/NCTE/F7/UP-3032/2008/63323 dated 25.09.2008.

2. **AND WHEREAS**, the revised recognition order was issued to the institution for conducting B.Ed. programme of two years duration with an annual intake of 200 students for (four basic units) of 50 students each from the academic session 2015-2016 vide order No. NRC/NCTE/UP-3032/2015/112995 dated 06.06.2015.

3. **AND WHEREAS**, the matter was placed before NRC in its 325th Meeting held on 08th to 09th January, 2021 and the Committee decided as under : -

" Consideration of the matter of Revised Recognition Orders(RRO)

Regional Director placed before the Committee, a list of 362 such institutions to whom RRO has not been issued till today due to not submission of required affidavit stating that institution will be comply with the conditions prescribed under Regulations, 2014, for consideration and decision of Committee.

The Committee discussed the matter in depth and decided to issue Show Cause Notice under Section 17 to institutions as per List put up before Committee for not making compliance to Regulations, 2014 "

Accordingly, Show Cause Notice under section 17 of NCTE Act, 1993 was issued to the institution vide letter No. F.NRC/NCTE/ (Item No. 107/Minutes of the 325th (Virtual) Meeting/2020/210876-211237 dated 19.01.2021.

4. **AND WHEREAS**, the institution has not submitted reply of Show Cause Notice under section 17 of NCTE Act, dated 19.01.2021. The matter was considered by NRC in its 403rd meeting (Online Mode) held on 13th & 14th July, 2023 and committee decided that Final Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 7 days from the date of issue of Show Cause Notice on the following grounds:

- The revised recognition order was not issued to the institution.
- As per decision of NRC in its 325th meeting the first show cause notice was issued to the institution on 19/01/2021.
- Reply of the First SCN has not been submitted by the institution.

5. **AND WHEREAS**, the institution has submitted reply dated 07.08.2023 of Final Show Cause Notice on basis of minutes uploaded in NCTE website. The matter was considered by NRC in its 412th meeting (Blended Mode) held on 25th September, 2023 and the committee decided as under:

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The recognition was granted to the institution for B.Ed. course of one years duration with an annual intake of 100 students vide order dated 08/07/2003 and B.Ed. additional intake of one year duration with an annual intake of 100 students vide order dated 25/09/2008.

The revised order for B.Ed. course of two years duration with annual intake of 200 students (four basic units) was issued to the institution vide order dated 06/06/2015.

As per decision of NRC in its 403rd meeting decided to issued Final SCN. The institution has submitted reply of final SCN on the basis of minutes uploaded in NCTE website vide letter dated 17/07/2023 & 7/08/2023. The NRC considered the reply submitted by the institution and observed the following:

- The institution has submitted all required documents against the Final SCN.

In view of the above, the NRC decided that recognition continuation order for B.Ed. and B.Ed. additional intake of two years duration with an annual intake of 200 students (two hundred) students be issued to the institution".

6. **NOW THEREFORE**, this order is issued permitting the institution **i.e. Abhinav Sewa Sansthan Mahavidyalaya, 81, Q Rajeev Puram, (Marana Pratap Nagar), Kanpur – 208091, Uttar Pradesh** for continuation of recognition for **B.Ed.** Programme for two-years duration with an annual intake of 200 (**four basic units**) of **50 students each** subject to fulfilment of the following :-

- (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



7. The institution shall submit to the Regional Committee as Self - Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter - alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- (a) Sanctioned programme(s) along with annual intake in the institution.
- (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left or joined during the last, quarter:
- (d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- (e) Fee charged from students;
- (f) Available infrastructural facilities;
- (g) Facilities added during the last quarter;
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

11. The institution shall make available the list of students admitted on its official website.

12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
