### **CONTINUATION ORDER**

2 9 SEP 2023

WHEREAS, the recognition under section 14(3)(a) of NCTE Act. 1993 was granted to the institution namely Inspiration College of Teachers Education, Polysheet, Po-Kathgodam, District- Nainital, Uttranchal for conducting B.Ed. Course of one-year duration with an annual intake of 100 (One Hundred) vide Order No. FNRC/NCTE/F-3/UR-19/4875-4884 dated 01.07.2005 and Revised Recognition Order for B.Ed. course of two years duration with an annual intake of 100 students (two units) 50 students each vide order No. NRC/NCTE/UR-19/2015/105020-25 dated 26.05.2015.

- 2. AND WHEREAS, the matter was considered by NRC in its 317<sup>th</sup> (Virtual) Meeting held on 22<sup>nd</sup> to 23<sup>rd</sup> September, 2020 and the Committee decided to issue Show Cause Notice Under Section 17(1) of NCTE Act, 1993 on the following grounds: -
  - 1. A notarized rent deed of the institution for 30 years has been submitted by the institution instead of a rent deed issued by Registrar/Sub-Registrar.
  - 2. The institution has not applied for shifting of premises from rented building after completion of stipulated period i.e. within 3 years of grant of grant of recognition as required by NCTE Regulations.
  - 3. The institution is required to submit compliance of Revised recognition Order issued during 2015 as per NCTE Regulation, 2014.

Accordingly, Show Cause Notice U/S 17 of NCTE Act, 1993 was issued to the institution on 06.10.2020.

- 3. **AND WHEREAS,** the institution has submitted reply of Show Cause Notice vide letter dated 05.11.2020. The matter was placed before NRC in its 322<sup>th</sup> (Virtual) meeting held on 07<sup>th</sup> December. 2020 and the committee decided to issue Final Show Cause Notice Under Section 17 on the following grounds:-
  - 1. The reply of the institution is still found deficient & insufficient in respect of Building plan, Building Completion Certificate, Building Safety Certificate, Current Fire Safety Certificate, Building Disabled Friendly Certificate, Current approved faculty list in NCTE prescribed proforma as per Clause-5 of Appendix- 4 of NCTE Regulations, 2014 as well as GOI No. 23<sup>-2</sup> dated 09.06.2017 by the concerned University alongwith all respective documents like affidavit of the faculty & management.
  - 2. FDRs are required for minimum 05 years as per Clause-10 of NCTE Regulations. 2014 in joint account, which is not followed by the institution. Revised FDRs are required to submit alongwith reasons of not preparing FDRs earlier under the provisions of NCTE.
  - 3. Downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014 has not been submitted.

Accordingly, Final Show Cause Notice U/S 17 (1) was issued to the institution on 03.02.2021.

4. AND WHEREAS, the institution has submitted reply of Final Show Cause Notice vide letter dt. 26.02.2021 & 10.04.2021. The matter was placed before NRC in its 338th Meeting held on 27th to 29th July, 2021 (Part-2) and the Committee decided that Land is on 30 Years Lease. No action is required.

- 5. AND WHEREAS, the matter was considered in NRC in its 410<sup>th</sup> meeting held on 04<sup>th</sup> & 05<sup>th</sup> Sep, 2023 and the Committee decided to issue Final Show Cause Notice Under Section 17 of the NCTE Act, 1996 on the following grounds:-
  - The institution is required to submit latest faculty list approved by the affiliating body.
  - The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement.

Accordingly, Final Show Cause Notice U/S 17 (1) was issued to the institution on 14.09.2023.

6. **AND WHEREAS**, the intuition has submitted reply of Final Show Cause Notice U/S 17 (1) on 12.09.2023. The matter was considered in NRC in its 411th meeting held on 15th September, 2023 in (Blended Mode) and the Committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The NRC in its 410th meeting decided to issued Final SCN. The institution has submitted reply of Final SCN on the basis of minutes uploaded in website vide letter dated 12/09/2023. The matter was considered in NRC and the committee observed the following:

• The institution has submitted all required documents.

In view of the above, the NRC decided that Recognition continuation order for B.Ed. course of two years' duration with an annual intake of 100 students (two units) be issued to the institution."

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Inspiration College of Teachers Education, Polysheet, Po-Kathgodam, District- Nainital, Uttarakhand for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of 100 (two basic units) subject to fulfilment of the following conditions:
  - (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their

teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- (a) Sanctioned programme(s) along with annual intake in the institution.
- (b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (c) Name of faculty members who left of joined during the last, quarter:
- (d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (e) Fee charged from students;
- (f) Available infrastructural facilities;
- (g) Facilities added during the last quarter;
- (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- (i) The affidavit with enclosure submitted along with application.
- (j) The institution shall be free to post additional relevant information if it so desires.
- (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
