CONTINUATION ORDER

WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Mariyam Institute for Higher Studies & Allied Courses, Abdullah Building, Bareilly Road, Haldwani, State-Uttarakhand, Pin Code-263139 for conducting B.Ed. Course of one-year duration with an annual intake of 100 (One Hundred) vide Order No. F.NRC/NCTE/UR-96/2008/59421-27 dated 27.08.2008 and revised recognition Order for B.Ed. course of two years duration with an annual intake of 100 students (two units) 50 students each was granted to the institution vide order No. NRC/NCTE/UR-96/2015/93285-290 dated 13.04.2015.

2. **AND WHEREAS**, as pre decision of NRC in its 333rd meeting held on 26th March, 2021. A Public Notice was issued to the institution on 30.03.2021.

3. **AND WHEREAS**, the institution has submitted reply of Show Cause Notice vide letter dated 13.04.2021 & 27.05.2021. The matter was placed before NRC in its 408th (Blended Mode) meeting held on 16th & 17th August, 2023 and the committee decided to issue Final Show Cause Notice Under Section 17 of NCTE Act, 1993 on the following grounds:-

- The institution is required to submit proof/ evidence to prove that it is a Multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution is required to submit Certified registered land documents issued by the Registering Authority
- The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
- The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- The institution is required to submit Certified copy of site plan with demarcated land area for running different courses.
- The institution is required to submit Building safety certificate from the Competent Government Authority.
- The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- The institution is required to submit Building Completion Certificate signed by the Competent Government Authority.
- The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management



- and Rs. 10/- non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma.
- The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly filled Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.
- Status of NAAC

Accordingly, Final Show Cause Notice U/S 17 of NCTE Act, 1993 was issued to the institution on 29.08.2023.

4. **AND WHEREAS**, the institution has submitted reply of Final Show Cause Notice U/S 17 of NCTE Act, 1993 on 04.09.2023 & 29.08.2023. The matter was placed in NRC in its 412th meeting held on 25th September, 2023 in (Blended Mode) and the Committee decided as under:-

"The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The recognition was granted to the institution for B.Ed. course of one year duration with an annual intake of 100 students vide order dated 27/08/2008.

The revised order for B.Ed. course of two years duration with annual intake of 100 students (two basic units) was issued to the institution vide order dated 13/04/2015.

As per decision of NRC in its 408th meeting Final SCN was issued to the institution on 29/08/2023. The institution has submitted reply of final SCN vide letter dated 04/09/2023 received in NRC Office on 12/09/2023. The NRC considered the reply submitted by the institution and observed the following:

- *The institution has submitted all required documents against the Final SCN.*

In view of the above, the NRC decided that recognition Continuation Order for B.Ed. course of two years duration with an annual intake of 100 students (two units) students be issued to the institution."

5. **NOW THEREFORE**, this Order is issued permitting the institution i.e. **Mariyam Institute for Higher Studies & Allied Courses, Abdullah Building, Bareilly Road, Haldwani, State-Uttarakhand, Pin Code-263139** for continuation of recognition for **B.Ed.** Programme of two-years duration with an annual intake of **100 (two basic units)** subject to fulfilment of the following: -

- (i) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.



- (iii) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- (iv) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain its Website with hyperlink to the Council and the Northern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- Sanctioned programme(s) along with annual intake in the institution.
- Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- Name of faculty members who left or joined during the last, quarter:
- Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- Fee charged from students;
- Available infrastructural facilities;
- Facilities added during the last quarter;
- Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

10. The institution shall make available the list of students admitted on its official website.

11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Northern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
