WHEREAS, the recognition under section 14(3)(a) of NCTE Act, 1993 was granted to the institution namely Jesus and Mary College, University of Delhi, Chanakyapuri, San Martin Marg, Chanakyapuri, Delhi, South Delhi, Delhi-110021 for conducting B.A. B.Ed. Course (Secondary) of four years' duration with an annual intake 10 (1 unit) from the academic session 2023-2024 vide Order No. F.No. NCTE/NRC/2324202205271202/DELHI/2022/Recognition Order dated 03.03.2023.

- 2. ANDWHEREAS, the matter was considered by NRC in its 398<sup>th</sup> and 400<sup>th</sup> meeting held on 09<sup>th</sup> & 10<sup>th</sup> May 2023 and 09<sup>th</sup> June 2023, wherein the NRC decided that Show Cause Notice u/s 17 be issued to the institution for not complying with the conditions of appointment of staff for the ITEP course as specified in the Recognition Order.
- 3. ANDWHEREAS, the Show Cause Notice as decided by NRC in its 398th and 400th meeting could not be issued however the institution vide letter dt. 23rd July, 2023 has submitted the compliance to the Recognition order.
- 4. ANDWHEREAS, the matter was considered by NRC in its 406<sup>th</sup> meeting held on 01<sup>st</sup> to 03<sup>rd</sup> August, 2023 wherein the NRC decided as under:-

"The Online application of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed following:

The NRC vide order dated 03<sup>rd</sup> March 2023 has granted recognition to the institution with the condition "The institution will appoint the faculty as per ITEP Regulations, 2021 before completion of the time limit given to them for the compliance of Lo1"

The institution did not comply with the condition as per ITEP Regulations, 2021 before completion of the time limit given to them for the compliance of LoI. Hence, recognition granted for the session 2023-2024 shall not be effective.

The NRC in its 398th and 400th meeting held on 09th-10th May 2023 and 09th June 2023 decided to issue First Show Cause Notice to the institution on account of above.

The institution vide its mail dated 23<sup>rd</sup> July 2023 has submitted the compliance to the condition as laid down in The Recognition Order.

After carefully observing the online application form, reply of SCN submitted by the institution, along with the other related documents, NCTE Act, Rules and Regulations, the Committee decided to grant recognition under clause 7(16) of the NCTE (Recognition Norms & Procedure) Regulations, 2014 as amended from time to time and order be issued to the institution for conduction Integrated Teacher Education Programme (ITEP) (B.A. B.Ed. —Secondary- One Unit) from the academic session 2024-2025."

- 5. As the institution is already recognised by NRC for ITEP course vide order dt. 03.03.2023, the matter is placed before NRC for review of its decision taken in 406 meeting.
- 6. AND WHEREAS, the matter was placed before NRC in its 410<sup>th</sup> meeting held on 04<sup>th</sup> & 5<sup>th</sup> September, 2023 Blended Mode and the committee decided as under:

"The Online application of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time were carefully considered by NRC and the Committee observed the following:

The NRC vide order dated 03<sup>rd</sup> March 2023 has granted recognition to the institution with the condition "The institution will appoint the faculty as per ITEP Regulations, 2021 before completion of the time limit given to them for the compliance of LoI"

The institution did not comply with the condition as per ITEP Regulations, 2021 before completion of the time limit given to them for the compliance of LoI. Hence, recognition granted for the session 2023-2024 shall not be effective.

The NRC in its 398th and 400th meeting held on 09th-10th May 2023 and 09th June 2023 decided to issue First Show Cause Notice to the institution on account of above.

The institution vides mail dated 23rd July 2023 has submitted the compliance to the Recognition order.

The NRC in its 406th meeting held on 01st to 03rd August 2023 has decided as under:

After carefully observing the online application form, reply of SCN submitted by the institution, along with the other related documents, NCTE Act, Rules and Regulations, the Committee decided to grant recognition under clause 7(16) of the NCTE (Recognition Norms & Procedure) Regulations, 2014 as amended from time to time and order be issued to the institution for conduction Integrated Teacher Education Programme (ITEP) (B.A. B.Ed.—Secondary-One Unit) from the academic session 2024-2025.

The NRC after detailed deliberation decided the following:

The institution is permitted to continue the course from the academic session 2024-2025, for which recognition has been granted by NRC vide order dated 03/03/2023.

Further the NRC also decided that the office of NRC need not implement the decision taken by NRC in its 406th meeting with regard to this institution."

7. NOW THEREFORE, this order is issued permitting the institution i.e. Jesus and Mary College, University of Delhi, Chanakyapuri, San Martin Marg, Chanakyapuri, Delhi, South Delhi, Delhi-110021 for continuation of recognition for B.A. B.Ed. (Secondary) Programme for four years' duration with an annual intake of 50 (one unit) subject to fulfilment of the following conditions:

- a) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations 2014, as amended from time to time.
- b) The intuition shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- c) The institution shall also fulfil of all such other requirements as may be prescribed by other regulatory bodies like UGC, Affiliating University / Body, the State Government etc. as applicable.
- d) The institution shall submit to the Regional Committee a Performance- Appraisal Report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- e) The institution shall maintain its own website with hyperlink to the NCTE website uploading the required information / documents as per clause 7(14) of the NCTE Regulations 2014 as amended time to time.
- f) The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on tis official website.
- g) If the Institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations, and orders made of issued there under, the action including withdrawal of recognition shall be taken by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
