RESTORATION ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to, Tanishk College of Education, Postal Address – 59/3, Rajpur Road, District - Dehhradun, State – Uttarakhand, Pin Code – 248001 for B.Ed. course with an annual intake of 100 seats vide order no. NRC/NCTE/F-7/UR-49/2005/7066-7075 dt. 27.07.2005 was issued to institution.

2. AND, WHEREAS, the inspection of the institution under section-17 of NCTE Act, 1993 was conducted by the inspection team of NRC. The Show Cause Notice dated 03.07.2009 was issued to the institution before withdrawn the recognition.

3. AND, WHEREAS, the said recognition was withdrawn by NRC vide order No. NRC/NCTE/F-3/UR-49/2010/19103-19109 dated 27.03.2010.

4. AND, WHEREAS, in compliance of order dated 08.06.2010 passed by the Hon'ble Division Bench High Court of Uttarakhand, fresh show cause notice dated 03.07.2010 was issued to the institution under section-17 of NCTE Act, 1993.

5. AND, WHEREAS, in compliance of order passed by Hon'ble High Court of Uttarakhand at Nainital in PIL 44/2009, the original file of the institution along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the Northern Regional Committee in its 163rd Meeting held from 29th to 31st July, 2010 and the committee observed the following: -

• The NCTE norms in respect of B.Ed. admission, infrastructure, etc. were not complied by the Institution. Hence the recognition of B.Ed. course of the Institution from academic session 2009 - 2010 is withdrawn.

6. AND, WHEREAS, in terms of above decision of NRC, the recognition was withdrawn by NRC vide order dated 03.09.2010.

7. AND, WHEREAS, the institution had filed a petition No. 1464/2010 before the Hon'ble High Court of Uttarakhand against the withdrawal of recognition. The Hon'ble High Court passed order dated 19.08.2010 in which the withdrawal order was stayed.

9. AND, WHEREAS, the matter was placed before NRC in its 299th Meeting held on 01st to 05th April, 2019 and the Committee decided that compliance with the order of the Hon'ble High Court of Uttarakhand at Nainital dated 31.10.2018, the recognition for the B.Ed. programme is restored.

NOW, THEREFORE, in exercise of the power vested under Section14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby restore the recognition granted to **Tanishk College of Education, Postal Address – 59/3, Rajpur Road, District - Dehhradun, State – Uttarakhand, Pin Code – 248001** for B.Ed. course with an annual intake of 100 seats vide order no. NRC/NCTE/F-7/UR-49/2005/7066-7075 dt. 27.07.2005.
