ORDER

17 DEC 2009

- WHEREAS **Haryana College of Education, Kinana, Jind, Haryana** had submitted an application to the Northern Regional Committee of NCTE, Jaipur for grant of recognition / permission for starting **(HR-321)** for **J.B.T.** course of two (2) years duration with an annual intake of 50 (Fifty only) students on 26.12.2005.
2. AND WHEREAS in its 107<sup>th</sup> Meeting (Second sitting) held on 07<sup>th</sup> - 09<sup>th</sup> September 2006, the Northern Regional Committee had decided to issue conditional recognition order. Accordingly conditional recognition order was issued on 09.09.2006. A clarification letter was issued on 12.11.2007. The institution submitted its reply on 02.06.2009. The reply submitted by the institution alongwith original file placed before the **NRC in its 141<sup>st</sup> meeting held on 22<sup>nd</sup> - 24<sup>th</sup> May, 2009**. The committee after considering the reply submitted by the institution, has decided to withdraw conditional recognition granted to the institution. Accordingly, Refusal order was issued vide order No. **F.NRC/NCTE/F-7-3/HR-321/2009/4253-59 dated 10.06.2009**.
3. AND WHEREAS the institution has preferred an appeal on **05.06.2009** against the refusal order of NRC dated **10.06.2009** to the appellate authority. The appeal of the institution was accepted and NRC's order dated **10.06.2009** was set aside by the appellate authority with direction to the NRC to re-examine the staff profile of the institution afresh ascertain whether it has been appointed as per NCTE norms and procedure. The matter was placed in the **149<sup>th</sup> NRC meeting held on 13<sup>th</sup> - 14<sup>th</sup> September, 2009** and the committee directs the Institution to submit the photocopies of the mark-sheets of appointed Faculty members. The institution has submitted the documents on 5.10.2009 and 15.10.09.
4. AND WHEREAS in its **152<sup>nd</sup> meeting held on 23<sup>rd</sup> to 25<sup>th</sup> November 2009** the original file of the institution, reply of the institution submitted in compliance of letter of intent issued under clause 7(9) along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered and the committee **decides to grant recognition under clause 7(11) of Regulations 2007**.
5. AND THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby **grants recognition** to **Haryana College of Education, Kinana, Jind, Haryana - 126102 for conducting J.B.T. Course of Elementary Level two years duration with an annual intake of 50 (Fifty only) students from the academic session 2009-2010** under clause 7(11) of NCTE Regulations, 2007 notified on 10.12.2007 subject to fulfillment of the following conditions as per the clarification from NCTE HQtrs letter No. file No. 48-3(1)/2008/NCTE/(N&S) dated 01.10.2009.
- The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.**
  - Formal orders for recognition / permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating body.**
6. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and Reserve fund account into a joint account to be operated along with an officer of the Northern Regional Committee.
7. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

8. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulation, 2007 notified on 10.12.2007.

9. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

11. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

12. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

13. In case if the land is in the name of the Society, you must transfer the land within six months in the name of institution failing which action shall be initiated to withdraw the recognition. It shall be essential on part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee alongwith the new land documents within stipulated time.
