WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely SSG College, Plot no. M-596, 597, Street no. G T Road, Vilalge- Mauhar, P.O.- Chaudgra, Tehsil- Bindki, Town- Fatehpur, Distt- Fatehpur, UP-212665 for D.El.Ed. course of two-year duration with annual intake of 50 (one unit) students from the academic session 2016-2017 vide order No. F.NRC/NCTE/Recognition/D.El.Ed./2016/142867-3467 dated 03.03.2016.

2. AND WHEREAS, a complaint letter No. PMOPG/D/2023/0208542 dated 29.09.2023 from Complaint Section-Hq received in NRC office on 06.10.2023 against the aforesaid institution for necessary action.

3. AND WHEREAS, the matter was placed before NRC in its 414th Meeting held on 06th to 07th October, 2023 and the Committee decided that first show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to the institution on the following grounds:-

- The institution is required to submit proof / evidence to prove that it is a Multi-disciplinary institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution is required to submit Certified registered land documents issued by the Registering Authority
- The institution is required to submit Blue print of approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area with the measurements of the Multi-purpose Hall as well other infrastructural facilities such as class rooms etc.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
- The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- The institution is required to submit certified copy of site plan with demarcated land area for running different courses.
- The institution is required to submit Building safety certificate from the Competent Government Authority.
- The institution is required to submit Fire safety certificate issued by the Competent Government Authority.
- The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.

- The institution is required to submit Building Completion Certificate signed by the Competent Government Authority.
- The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/ Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative not submitted. And, notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/ appointed faculty in the NCTE prescribed proforma.
- The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty members.
- The institution is required to submit original valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- The institution is required to submit downloaded copies of documents from the website of the institution with hyperlinks of the same as per provisions of 7(14) of the NCTE Regulations, 2014.
- The institution has not adhere to the mandatory disclosure in the prescribed format and display up to date information on its official website as per NCTE Regulations 8(14) condition for grant of recognitions as per NCTE Regulations 2014.
- Status of NAAC.
- A complaint received from Smt. Abhilasha through PMOPG/ D/2023 /0208542 against the institution. The institution is required to submit point wise reply in respect of complaint.

Hence, the NRC decided that First Show Cause Notice Under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 15 days from the date of issue of Show Cause Notice on the grounds mentioned above.

4. **AND WHEREAS**, show cause notice was issued to the institution on 10.10.2023. The institution has not submitted any reply of show cause notice dated 10.10.2023.

5. **AND WHEREAS**, the matter was placed before NRC in its 435th meeting held (Volume-1) on 03rd & 04th March, 2025 and the Committee decided as under:-

- The institution is required to submit proof /evidence to prove that it is a multi-disciplinary institution as per clause 2(b) of NCTE Regulations 2014.
- The institution is required to submit Certified registered land documents issued by the Registering Authority in respect of Khasra No. 309/235 & 237.

- The institution is required to submit blue print of approved building plan signed by the Competent Govt. Authority indicating the name of the course, Name of the institution, Khasra no. /plot no., total land area, total built-up area, earmarked total land & built-up area along with approval letter.
- The institution is required to submit Land Use Certificate issued by the Competent Government Authority to use the land for educational purpose in respect of Khasra No. 309/235 & 237.
- The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
- The institution is required to submit Certificate copy of site plan with demarcated land area for running different courses.
- The institution is required to submit Building Safety Certificate issued by the Competent Government Authority.
- The institution is required to submit Fire Safety Certificate from the Competent Government Authority.
- The institution is required to submit Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- The institution is required to submit Building Completion Certificate signed by the Competent Authority.
- The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/ Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related documents duly attested by authorized management representative along with notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/- non-judicial stamp paper by each selected/ appointed faculty in the prescribed proforma is required to be submitted.
- The institution is required to submit details of salary disbursed to the faculty along with one year Bank statement and account number of each faculty member.
- The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/ Scheduled Bank towards Endowment & Reserve Fund in the joint name of RD, NRC, NCTE & the representative of Management along with duly filled up Form "A" in original, verified/ signed by the Manager of the Bank as per NCTE Regulations, 2014.
- The institution is required to submit information related to uploading of requisite documents and displaying same on the website of the institution with hyperlinks is

the same as per provisions of 7(14) (i), 8(14) and 10(3) of the NCTE Regulations, 2014.

- Point-wise reply on the compliant made by Smt. Abhilasha through PMOPG/D/2023/0208542 against the institution.

Hence, the Committee decided that Final Show Cause Notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 15 days from the date of issue of Final Show Cause Notice.

5. **AND WHEREAS**, final show cause notice was issued to the institution on 11.04.2025. The institution had submitted reply of final show cause notice vide letter dated 11.04.2025 received in NRC office E-receipt No. 367556, 367537 dated 06.06.2025.

6. **AND WHEREAS**, the matter was considered NRC in its 442nd Meeting held on 11th & 12th June, 2025 and the Committee considered the reply dated 14.02.2025 and observed the following.

- The institution has not submitted the certified land documents in respect of Khasra No. 598m, 597 m. The institution has submitted photocopy of land documents.
- The institution has submitted building plan for B.Ed. & D.El.Ed. singed by Abhiyanta, Jila Panchyat, Fatehpur. As per building plan, total built up area is only 2556.84 Sqm. which is not sufficient for offering two units B.Ed. and one unit of D.El.Ed. course.
- The institution has submitted NEC issued by Deputy Registrar Bindki, Fatehpur in respect of Khasra No. 596, 594, 597 for the period of 02.08.2010 to 27.02.2024. The latest NEC is not submitted by the institution.
- The institution has submitted site plan (Nazari Naksa). Issuing authority of the said site plan is not clear.
- The institution has submitted the building safety certificate dated 22.03.2015 issued by Adhishashi Abhiyanta, PWD, Fatehpur. The latest building safety certificate is not submitted by the institution.
- The institution has submitted photocopy of BCC which is not readable. As per BCC, total built-up area is 4000 Sqm. and as per building plan, total built-up area is 2556.84 Sqm. The built-up area mentioned is BCC and building plan does not match.
- The recognition was granted to the institution for B.Ed. two units (100 students). For two units, 1+15 faculty is required but the institution has submitted approval letter dated 27.02.2015 issued by CSJM University, Kanpur in respect of one HOD & Nine Assistant Professor(s). the details of the six Assistant Professors is not submitted by the institution. The institution has not submitted the latest faculty approval letter issued by affiliating body and the consolidated chart signed by affiliating body is also not submitted.
- The institution has not submitted faculty approval letter for D.El.Ed. Course issued by affiliating body.

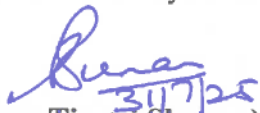
- The institution has not submitted the FDRs of Rs. 5+7 Lakh for each B.Ed. & D.El.Ed. in original.
- The institution has also not filled PAR for B.Ed. & D.El.Ed. Course for the Session 2021-22 & 2022-2023.

Hence, the Committee decided that that recognition granted to the institution for offering B.Ed. course be withdrawn under section 17(1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026 onwards.

7. **NOW THEREFORE**, in terms of the above decision of NRC, the recognition granted to the institution namely SSG College, Plot no. M-596, 597, Street no. G T Road, Vilalge- Mauhar, P.O.- Chaudgra, Tehsil- Bindki, Town- Fatehpur, Distt- Fatehpur, UP-212665 is hereby withdrawn for conducting D.El.Ed. course with effect from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026 onwards.

8. Further, if the institution is not satisfied with the order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
