**CHANGE IN THE NAME OF INSTITUTION AND AFFILIATING BODY**

WHEREAS, the recognition was granted to the institution namely **Srimati Manjira Devi Shikshan Avam Prashikshan Institute, Hitanu Dhanari, Pujar Gaon, Uttarkashi-249193, Uttarakhand** for conducting **B.Ed.** course of one-year duration with an annual intake of 100 students vide Order No. F. No. NRC/NCTE/NRCAPP-NRC/NCTE/F-3/UR-22/4865-74 dated 01.07.2005 followed by revised recognition order for B.Ed. two year duration with an annual intake of 100 students i.e. two basic units of 50 students each vide order dated **25.05.2015**.

2. **AND WHEREAS**, the sponsoring Society of the above institution i.e Srimati Manjira Devi Shikshan Avam Prashikshan Samiti has established a Private University namely Srimati Manjira Devi University vide Gazette Notification dated No. 114/XXXVI (3)/2024/13(1)2024 dated 16/03/2024 under provisions of the Uttarakhand Private Niji Vishwavidyalaya (Amendment) Act, 2024 (Act No. 5 of 2024).

3. **AND WHEREAS**, the Society/University vide letter dated 07/07/2025 has requested the Northern Regional Committee to change the name of the institution as Srimati Manjira Devi University and to change the affiliating University as Srimati Manira Devi University to offer its B.Ed. Course.

4. **AND WHEREAS**, the matter was placed before NRC in its 443<sup>rd</sup> Meeting (Volume-2) held on 09<sup>th</sup> & 10<sup>th</sup> July 2025, and the Committee decided as under: -

*"The Original file of the institution along with other related documents, NCTE Act, 1993, Rules, Regulations, SOP, guidelines issued from time to time were placed before the Northern Regional Committee and the Committee observed the following: -*

- The recognition was granted to the institution namely **Srimati Manjira Devi Shikshan Avam Prashikshan Institute, Hitanu Dhanari , Pujar Gaon, Uttarkashi-249193, Uttarakhand** for conducting **B.Ed.** course of one-year duration with an annual intake of 100 students vide Order No. F. No. NRC/NCTE/NRCAPP-NRC/NCTE/F-3/UR-22/4865-74 dated 01.07.2005 followed by revised recognition order for B.Ed. two year duration with an annual intake of 100 students (two units) vide order dated **25.05.2015**.
- The above institution running under the Srimati Manjira Devi Shikshan Avam Prashikshan Samiti has now established a Private University namely Srimati Manjira Devi University vide Gazette Notification dated No. 114/XXXVI (3)/2024/13(1)2024 dated 16/03/2024 under provisions of the Uttarakhand Private Niji Vishwavidyalaya (Amendment) Act, 2024 (Act No. 5 of 2024). The society/University vide letter dated 07/07/2025 has requested the Northern Regional Committee to change the name of the institution located as Srimati Manjira Devi University and to change the affiliating University as Srimati Manira Devi University to offer its B.Ed. 

In view of the above, the Committee considered the matter and permitted as under: -

- a) The name of the institution be changed from Srimati Manjira Devi Shikshan Avam Prashiksahn Institute, Hitanu Dhanari, Pujar Gaon, Uttarkashi-249193 Uttarakhand to The School of Arts and Humanities, Srimati Manjira Devi University, Hitanu Dhanari, Pujar Gaon, Uttarkashi-249193 Uttarakhand for offering B.Ed. Course from the academic session 2025-2026 with an annual intake of 100 students i.e. two basic units of 50 students each.
- b) The name of affiliating body be changed from HNB Garhwal University, Srinagar, Pauri Garhwal University to Srimati Manjira Devi University, Hitanu Dhanari, Pujar Gaon, Uttarkashi-249193 Uttarakhand for offering B.Ed. Course from the academic session 2025-2026 with an annual intake of 100 students i.e. two basic units of 50 students each."

NOW THEREFORE, in terms of above decision of NRC, the institution namely Srimati Manjira Devi Shikshan Avam Prashiksahn Institute, Hitanu Dhanari, Pujar Gaon, Uttarkashi-249193 Uttarakhand is hereby permitted to change its name as the School of Arts and Humanities, Srimati Manjira Devi University, Hitanu Dhanari, Pujar Gaon, Uttarkashi-249193 Uttarakhand and also to change the affiliating body from HNB Garhwal University, Srinagar, Pauri Garhwal University to Srimati Manjira Devi University, Hitanu Dhanari, Pujar Gaon, Uttarkashi-249193 Uttarakhand for offering B.Ed. Course from the academic session 2025-2026 with an annual intake of 100 students i.e. two basic units of 50 students each.


