5. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations 2014, as amended from time to time.

6. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

7. The instituton shall also fulfil of all such other requirements as may be prescribed by other

- regulatory bodies like UGC, Affiliating University / Body, the State Government etc., as applicable.*
- 8. The institution shall submit to the Regional Committee a Performance-Appraisal Report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.*

- 10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.*
- 11. If the Institution Contravenes any of the provisions of the NCTE Act, Rules, Regulations, and orders made or issued thereunder, the action including withdrawal of recognition shall be taken by the Regional Committee concerned under the provisions of Section 17(1) of the NCTE Act 1993.*
