## WITHDRAWAL ORDER

WHEREAS, the recognition was granted to the institution namely Rashida Begam Muslim Mahavidyalaya, Bijnor Road, Amroha, J.P. Nagar-244221, Uttar Pradesh for conducting B.Ed. course of one year duration with annual intake of 100 (One Hundred) students from the academic session 2004-2005 vide order No. F.NRC/NCTE/F-3/UP-739/3559 dated 06.07.2004 followed by the revised recognition order for B.Ed. course of two-year duration with an annual intake of 100 students from the academic session 2015-2016 vide order No. F. No./NRC/NCTE/UP-Common Order/2015/111718-45 dated 05.06.2015.

- 2. **AND WHEREAS,** a complaint letter F. No. NCTE-C/PG011/10/2024-Complaint Section-HQ dated 25.09.2024 was received from NCTE (HQ) vide for necessary action.
- 3. **AND WHEREAS,** the matter was considered NRC in its 430<sup>th</sup> meeting (Volume-1) held on 28<sup>th</sup> & 29<sup>th</sup> November 2024, and the Committee decided that Show Cause Notice under Section 17 of the NCTE Act, 1993 be issued to the institution on the following grounds:
  - The institution is required to submit proof/evidence to prove that it is a multi-disciplinary institution as per clause 2(b) of NCTE Regulations 2014.
  - The institution is required to submit Certified registered land documents issued by the Registering Authority.
  - The institution is required to submit blueprint of approved building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra no./plot no. total land area, total built-up area, earmarked total land & built-up area along with approval letter.
  - The institution is required to submit land Use Certificate issued by the Competent Government Authority to use the land for educational purpose.
  - The institution is required to submit Non-Encumbrance Certificate issued by the Competent Government Authority indicating that the land is free from all encumbrances.
  - The institution is required to submit Certificate copy of site plan with demarcated land area for running different courses.
  - The institution is required to submit Building safety certificate issued by the Competent authority.
  - The institution is required to submit Fire safety certificate from the Competent Government Authority.
  - The institution is required to submit Certificate to the effect that the building is differently bled friendly from the Competent Government Authority.

- The institution is required to submit Building Completion Certificate signed by the Competent Authority.
- The institution is required to submit latest/current faculty list approved & signed each page by concerned affiliating body in original with the details of their teaching subject, date of birth, date of selection, date of joining, academic qualifications, teaching experience, NET/Ph.D. (NCTE's GOI dated 09.06.2017), salary structure and related document duly attested by authorized management representative not submitted. And notarized original affidavit of Rs. 100/- on non-judicial stamp paper by the management and Rs. 10/ non-judicial stamp paper by each selected/appointed faculty in the NCTE prescribed proforma is required to be submitted.
- The institution is required to submit details of salary disbursed to the faculty along with six months Bank statement and account number of each faculty member.
- The institution is required to submit copies of valid Fixed Deposit Receipts Nationalized/Scheduled Bank towards Endowment & Reserve Fund in the joint operation mode with RD, NRC, NCTE & Management along with duly field Bank Form "A" in original, verified/signed by the Manager of the Bank as per NCTE Regulations, 2014.
- The institution is required to submit information related to uploading of requisite documents and displaying same on the website of the institution with hyperlinks of the same as per provisions of 7(14)(i), 8(14) and 10(3) of the NCTE Regulations, 2014.
- **5. AND WHEREAS,** show cause notice was issued to the institution on 10.01.2025. The institution had submitted reply of SCN vide letter dated 29.01.2025 received in NRC office E-receipt no. 356343 dated 13.02.2025.
- 6. **AND WHEREAS**, the matter was considered NRC in its 442<sup>nd</sup> Meeting held on 11<sup>th</sup> & 12<sup>th</sup> June, 2025 and the Committee considered the reply dated 29.01.2025 and observed the following.
  - The institution has submitted land documents Khasra No. 403,404 & 402 whereas the institution was granted recognition at Khasra No. 601k, 602kha and 603k, Village-Nizampur, Garvi Amroha. The institution has changed the location of the institution without prior permission of NCTE. The institution submitted the land documents for Khasra No. 403, 404 & 402 village, Nizampur Garvi which is a water body land as per the National Green Tribunal, Principal Bench, New Delhi in Application No. 219/204 (1A No. 644/2024, 1A No. 402/2024) titled as Syed Ashhar Tauseef Vs Kamal Faruqui Order dated 17.02.2025.
  - The institution has not submitted building plan approved by Competent Government Authority.
  - The institution has not submitted CLU in respect of Khasra No. 601K, 602 Kh, 603K rather the institution has submitted the Land Use Certificate in respect of Khasra No. 403 & 404 & 402 which is not applicable as the institution has not been granted recognition on these Khasra numbers.
  - The institution has not submitted NEC in respect of Khasra No. 601K, 602Kh, 603K. The NEC submitted is in respect of Khasra No. 402, 403, 404 which is not acceptable.
  - The institution has not submitted site plan in respect of Khasra No. 601K, 602Kh, 603K.

- The institution has not submitted building safety certificate in respect of Khasra No. 601K, 602Kh, 603K.
- The institution has submitted fire safety certificate dated 04.04.2024 but building is not situated at Khasra No. 601K, 602Kh, 603K.
- The institution has not submitted Certificate to the effect that the building is differently abled friendly from the Competent Government Authority.
- The institution has submitted list of 8 faculty only which is not approved by the affiliating body. The institution has not appointed faculty in respect of Fine Art, Performing Art and Physical Education.
- The institution has submitted photocopy of FDR's, however, the institution not submitted form "A" issued by concerned Bank.

Hence, the Committee decided that that recognition granted to the institution for offering B.Ed. course be withdrawn under section 17(1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026 onwards.

- 7. NOW THEREFORE, in exercise of the powers vested under Section 17(1) of the NCTE Act, 1993, the Northern Regional Committee decided to withdraw the recognition of the institution namely Rashida Begam Muslim Mahavidyalaya, Bijnor Road, Amroha, J.P. Nagar-244221, Uttar Pradesh for B.Ed. course with effect from the end of academic session next following the date of communication of withdrawal order and the institution shall not be entitled to admit the students from the academic session 2025-2026 onwards.
- 8. Further, if the institution is not satisfied with the order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
