 - The institution shall comply with the various other norms and standards (11)prescribed in the NCTE Regulations, as amended from time to time.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.
