8. The institution shall submit to the Regional Committee a Performance-Appraisal Report (PAR) at the

end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
