ORDER

In exercise of the powers vested under Section 14(i)(a) of the National Council for Teacher Education (NCTE) Act, 1993, the Northern Regional Committee grants affiliation to Aligarh Muslim University, Department of Education, Aligarh (U.P.) to run One Year (2000-2001) with an annual intake of 100 One Hundred students subject to fulfil the following conditions:

1. The institution shall appoint a Director to fulfill the conditions laid down in this order.
2. The institution shall provide library, laboratories and other instructional infrastructure as per the NCTE norms.
3. The institution shall appoint a sufficient number of qualified teachers as per the norms laid down in this order.
4. The institution shall appoint a sufficient number of staff as per the norms laid down in this order.
5. The institution shall appoint a sufficient number of students as per the norms laid down in this order.
6. The institution shall follow the structure and syllabus of the affiliated University/State Government till such time NCTE regulations in respect of structure and syllabus are notified.
7. The institution shall organize regular work activities, should be organized in the form of assignments, projects, seminars and the requirements of the affiliated University/State Government.
8. The institution shall not be less than the number of students as per the norms laid down in this order.
9. The institution shall follow the structure and syllabus of the affiliated University/State Government till such time NCTE regulations in respect of structure and syllabus are notified.

The institution shall continue to follow the norms laid down under the regulations of the NCTE and submit to the National Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report shall inter alia give the extent of compliance of the conditions laid down in this order.


