ORDER

Whereas CES College of Educational Research and Training, Pitam Pura, Delhi was granted recognition vide order dated 6th June 1999 to conduct B. Ed course with an annual intake of 60 students from the academic session 1999-2000 and subsequently vide order No. F.NRC/NCTE/F-3/DH-148/2003/1938-1946 dated 26th June 2003; the intake was enhanced to 100 so as to make a unit of 100 seats from the academic session 2003-2004.

AND WHEREAS, NRC in its 99th meeting, in proceedings initiated under Section 17 of the NCTE Act, 1993, decided to withdraw the above order granting recognition to the Institution for B. Ed course. Pursuant to it, the office of NRC issued a formal order dated 27th January 2006.

AND WHEREAS, the Appellate Authority, NCTE- HQrs vide its order dated 19th July 2006, in an appeal preferred before it, reversed the order of NRC.

AND THEREFORE, in pursuance of the order of Appellate Authority, NCTE- HQrs the NRC withdraws its order dated 27th January 2006 and the order issued by this office dated 26th June 2003 granting recognition to the institution for B. Ed course is restored to continue and remain in force till further orders.

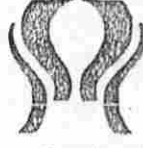
