ORDER

Ideal Institute of Management and Technology, 124, Parpar Ganj, Industrial Area, Delhi-110092 had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for an additional intake of seats so as to complete one unit, i.e., 100 (One Hundred) seats in B.Ed. course of One year duration from the academic session 2003-2004 in terms of Section 14 (1) of the NCTE Act, 1993.

- On scrutiny of the application submitted by the institution, the documents attached therewith and the input 2. received from the visiting team, the Committee has noted the following :-
 - The institution has acquired the land for setting up the teacher education institution.
 - (ii) The institution has created an Endowment Fund of Rs 5,00,000/- (Rupees Five Lacs Only) and a Reserve Fund of Rs. 3,00,000/- (Rupees Three Lacs Only).
 - (iii) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.
- Now, therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Ideal Institute of Management and Technology, 124, Parpar Ganj, Industrial Area, Delhi-110092 for an additional intake of Forty Seats (Total=100 Seats) seats in B.Ed. course of One year duration from the academic session 2003-2004 subject to fulfillment of the following before the commencement of the session-
 - Appointment of the faculty members duly qualified and staff as per the norms of NCTE/State Govt./UGC is to be completed before the commencement of the session.
 - The countersigned statement of all faculty members from the Registrar of the concerned (b) University should be submitted before the commencement of the academic session 2003-2004.
 - The institution shall adhere to all the other regulations and guidelines as framed by NCTE from (c) time to time.
 - The institution shall within ONE MONTH of the receipt of recognition order, convert the (d) Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
 - That the Reserve Fund for an amount equal to three months salary of the staff be maintained, in (e) the form of FDR in favour of the management / institution, for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank.
 - Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.
