ORDER

Whereas, Management Education and Research Institute (MERI), 53-54, Institutional Area, Pankha Road, Opp. D- Block, Janakpuri, New Delhi- 110058 was granted recognition for B.ED Course of one year duration from the academic session 2004-2005 with an annual intake of 100 students vide this office order no. F.NRC/NCTE/F-3/DH-194/2002/5744-5752 dated 12.11.2003.

And whereas, NRC vide its letter no. F.NRC/NCTE/F-7/DH-194/2008/65536-65541 dated 12.11.2008 decided to allow the change of premises of Management Education and Research Institute (MERI), 53-54, Institutional Area, Pankha Road, Opp. D- Block, Janakpuri, New Delhi- 110058 to Management Education and Research Institute (MERI), Ram Krishna Senior Secondary School, M- Block, Vikas Puri, New Delhi- 110018 at the end of the current academic session.

And whereas, as per the direction of Hon'ble High Court of Delhi vide its order dated 25.11.2009, inspection was conducted by two VT members on 03.12.2009 and the VT report has been received. The VT report was to be produced before the Hon'ble Court on 07.12.2009 for further directions. However, the VT report and the order from the Hon'ble High Court were placed before the 152^{nd} (2^{nd} Sitting) meeting held on 06.12.2009 and the committee decided to issue a show cause notice to the institution. Accordingly, show cause notice was issued to the institution on 15.01.2010.

And whereas, the applicant institution has submitted its representation dated 04.03.2010 to the NRC. The matter was considered by the NRC in its 160^{th} meeting held on 18^{th} to 20^{th} May, 2010 and the committee observes the following:-

- The deficiency related to the requirement of Land still exists.
- · Land is still not in the name of the Institution.
- As per record, DDA allotted land for running school but not B.Ed. programme.
- As per the submitted reply the Computer lab and science lab are being shared with the School.

Hence, the committee decides to withdraw the recognition of B.Ed. programme from academic session 2010-2011.

Now therefore recognition granted to Management Education and Research Institute (MERI), Vikas Puri, Rama Krishna Sr. Sec. School, M Block, New Delhi West, New Delhi-110018 for the course in **B.ED** in term of section 17(1) of the NCTE Act, 1993 is hereby withdrawn from the academic session 2010-2011.

 - (c) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only).
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTR Act, 1993, the Regional Committee hereby grants recognition to Management Education & Research Institute, 53-54, Institutional Area, Pankha Road, Opp. D-Block, Janak Puri, New Delhi - 110058 for B.Ed. course of One year duration from the academic session 2004-2005 with an annual intake of 100 (One Hundred) students Subject to fulfillment of the following before commencement of the session:
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / UGC is to be completed before the commencement of the
 - (b) The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2004-2005.
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional committee.
 - (e) That the Reserve Fund for an amount equal to three months salary of the teachers & staff be maintained in the form of FDR in favor of the management/ institution, for a period of not less than sixty months (five years) in a
 - (f) Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.

- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
