Withdrawal Order

WHEREAS, in terms of section 14 of the NCTE Act, 1993 Triveni Educational & Social Welfare Society, C-1/169, Janak Puri, New Delhi -110058 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the Ramakrishna Teachers Training Institute, M-Block, Vikas Puri, New Delhi -110018 for B.Ed. course of one year duration for an intake of 100 (One Hundred Only) students on 05.08.2003. The recognition was granted to the institution for B.Ed. Course of one year duration with an annual intake 100 (One Hundred Only) students vide NRC order No. F.NRC/NCTE/F-3/DH-196/2002/5087-95 dated 23.10.2003.

AND WHEREAS, the matter was placed in its 190th meeting of the NRC held from December 6th to 8th, 2011 and it was observed that the land has been leased by DDA for running Nursery School. Hence, NRC decided that VT be constituted u/s 17 of NCTE, Act, 1993 for qualified staff, their salary payment mode etc. as per NCTE Norms. Accordingly, that inspection of the institution was conducted u/s 17 on 16.02.2012

AND WHEREAS, the VTR was again placed before NRC in its 197th meeting held from 12th to 14th April, 2012. And following observations have been made :-

- VT report was seen. No B.Ed. College is being run in the name of Ram Krishna Teachers Training Institute, M Block, Vikaspuri, New Delhi at present. The Hon'ble High Court may be apprised about the fact.

AND WHEREAS, the matter was again placed in its 198th meeting of the NRC held from 20th to 27th April 2012 and it was decided that Show Cause notice u/s 17 of NCTE Act, 1993 be issued to the institution on the following point before withdrawal of recognition. Accordingly, a Show Cause Notice dated 22.05.2012 was issued to the institution on the following grounds :-

- The institution was granted recognition for starting B.Ed. course vide letter F.NRC/NCTE/F-3/DH-196/2002/5087-5095 dated 23rd October, 2003 on the basis of NOC of Govt. of N.C.T. of the Delhi office of the Directorate of Higher Education dated 20.5.2003 and other required documents submitted by the institution.
- A Visiting Team constituted by NRC visited the premises of the institution on 16.2.2012. The VT reported that B.Ed. course has never been started by the institution.
- A letter dated 27.04.2012 was received from the Guru Govind Singh Indraprastha University on 09.05.2012.

AND WHEREAS, the matter was again considered by NRC in its 206th meeting held from October 17-15, 2012 and Committee discussed and considered the case in detail and following observations were made:-

- The institution vide its letter dated 07.02.2012 has informed the NRC that "the institution has never functional in the absence of affiliation from the affiliating university".
- GGSU University vide its letter 27.04.2012 has informed that NRC that "the institution is not a provisionally affiliated institute of the university".
- A VT constituted by NRC visited the premises of the institution on 16.02.2012. The VT reported that B.Ed. Course has never been started by the institution.




Hence, NRC decided that the grant of recognition of said course be treated as withdrawn with immediate effect. FDRs, if any be returned.

NOW THEREFORE, in exercise of the powers vested under section 17(1) of NCTE Act, 2009, the Northern Regional Committee hereby withdraw the above recognition granted to Trinity Institute of Higher Education, D-Block, Adj. to Kamal Public School, Vikas Puri, Delhi-110018 for B.Ed. course of one year duration for an intake of 100 (One Hundred Only) students on the grounds mentioned above. The original FDR of submitted by the institution are returned herewith.

ORDER

Rama Krishna Teachers Training Institute, M-Block, Vikas Puri, New Delhi - 110018 had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting B.Ed. Course of One year duration in terms of Section 14(1) of the NCTE Act, 1993

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course on the above mentioned land.
- The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs. 3,95,613.00 (Rupees Three Lacs Ninty Five Thousand Six Hundred Thirteen Only).

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to 1993 Rama Krishna Teachers Training Institute, M-Block, Vikas Puri, New Delhi - 110018 for B.Ed. course of One year duration from the academic session 2003-2004 with an annual intake of 100 (One Hundred) students Subject to fulfillment of the following before commencement of the session :-

- Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / UGC is to be completed before the commencement of the session.
- The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2003-2004.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional committee.
- That the Reserve Fund for an amount equal to three months salary of the teachers & staff be maintained in the form of FDR in favor of the management/ institution, for a period of not less than sixty months (five years) in a Nationalized Bank.
- Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.

4. Recognition is subject to the condition that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating University.

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
