ORDER

District Institute of Education & Training, X-27,28,29, Karkardooma Institutional Area, Delhi - 110 092 had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for additional intake in ETE Course of two years duration in terms of Section 15(1) of the NCTE Act, 1993.

8. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to District Institute of Education & Training, X-27,28,29, Karkardooma Institutional Area, Delhi - 110 092 for ETE course of Two years duration w.e.f. 17th December 2004 with an additional intake of 40, thereby making the annual intake of the institution to 100 (One Hundred only) i.e. 100 students in the 1st year and the same for the 2nd year subject to fulfillment of the following before commencement of the session :-

- (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / SCERT is to be completed before the commencement of the academic session.
- (b) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional committee.
- (e) That the Reserve Fund for an amount equal to three months salary of the teachers & staff be created within one month from the date of issue of this order and maintained in the form of FDR in favor of the management/ institution, for a period of not less than sixty months (five years) in a Nationalized Bank.
- (f) Before starting the course the institution should seek prior permission of the competent authority for conducting the exams and approval of the curriculum that they are going to adopt for the course.
- (g) Institutions if starts the training programme without prior approval / permission of the competent authority / examining body regarding the curriculum that they have adopted and conduct of examinations for award of Diploma / Certificate the recognition of such institutions shall stand withdrawn.
- (h) Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.


4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
