ORDER

WHEREAS, the institution, namely, Bharti Institute of Rural Development, Rafilal, No. 05, Nav Vikas Apartments, Sector-15, Rohini, Delhi – 110 085 has made an application to Northern Regional Committee (in short NRC) under section 14 (1) of NCTE Act, 1993 to seek permission to start new course of NTT from academic session 2004-2005 vide covering letter dated 28.01.2004 and the same was received in the office of NRC on 29.01.2004.

- 3. AND WHEREAS, the institution was inspected on 14.06.2004 by an inspection team of experts constituted by NRC. The inspection team noted certain deficiencies in its report submitted and the same were considered by NRC in its 79^{th} meeting held on 23-24th June 2004 alongwith the original file of the institution.
- 4. AND WHERAS, NRC after careful perusal of the file, inspection report of the experts and other related documents, the Committee, in the above meeting, being satisfied that the institution did not fulfill the requirements laid down in sub clause (a) of section 14 (3) of NCTE Act, 1993 decided that the institution be given a reasonable opportunity for making representation drawing its attention with following deficiencies existed vis-à-vis NCTE norms:
- Building plan submitted is not approved by the local competent authority.
- Reserve fund equivalent to three months salary of the staff has not been provided.
- Books and journals are not provided in the library.

5. AND WHEREAS, the institution submitted its written representation vide letter dated 19th July 2004 which was received in the office of NRC on 19.07.2004. The said representation was placed before the NRC in its 81st meeting held on 11-12th August 2004, wherein the Committee, after consideration of the entire matter including the deficiencies referred to above, being satisfied that the institution has complied with the deficiencies pointed above, decided to grant recognition to the institution for NTT course of two years duration with an annual intake of 50 students.

- 6. AND accordingly, as per the decision of NRC, the Recognition order dated 24th August 2004 was issued to the institution.
- 7. AND WHEREAS, the institution vide its letter dated 10th March 2005 has requested to stop further process and return the FDR for Rs. 5.00 lakks submitted alongwith the application.
- 8. AND WHEREAS, the said representation was placed before the NRC in its 91st meeting held on 20th-21st May 2005, wherein the Committee decided that the request of the institution be accepted and decided to withdraw recognition granted to the institution for NTT course under Section 17 of the NCTE Act, 1993.
- 9. AND THEREFORE, the institution shall not admit any student in NTT course and other concerned body(s) shall not hold examination, whether provisional or otherwise for the NTT course if conducted by the said institution unless the institution is granted permission for the said course by the NRC/NCTE. In accordance with section 17 (4) of the NCTE Act, 1993, the qualification in teacher education, namely NTT, obtained pursuant to such course or training in the above institution shall not be treated as valid qualification for purposes of employment under the Central Government, any State Government or University, or in any School, College or other educational body aided by the Central Government or any State Government.
- 10. Further, if the institution is not satisfied by this order, it can prefer an appeal before National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of NCTE Act, 1993, within 60 days of the date of issue of this order. The guidelines for appeal are enclosed herewith.

ORDER

Bharati Institute of Rural Development, Rafilal, No. 5, Nav Vikas Apartments, Sector-15, Rohini, Delhi – 110 085 had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for starting NTT Course of Two years duration in terms of Section 14(1) of the NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Bharati Institute of Rural Development, Rafilal, No. 5, Nav Vikas Apartments, Sector-15, Rohini, Delhi 110 085 for NTT course of Two years duration from the academic session 2004-2005 with an annual intake of 50 (Fifty) students in the 1st year and the same for the IInd year subject to fulfillment of the following before commencement of the session:
 - (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / SCERT is to be completed before the commencement of the session.
 - (b) The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session 2004-2005.
 - (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
 - (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional committee.
 - (e) That the Reserve Fund for an amount equal to three months salary of the teachers & staff be created within one month from the date of issue of this order and maintained in the form of FDR in favor of the management/ institution, for a period of not less than sixty months (five years) in a Nationalized Bank.
 - (f) Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.
- 3. Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/State Govt /Affiliating Body.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 5. The institution shall submit to the Regional Committee a <u>Self-Appraisal Report</u> at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
