WHEREAS in terms of Section 15 of the NCTE Act, 1993, **M. A. Educational Institute, Pocket - H - 3, Sector - 18, Rohini, Delhi - 110042** has submitted an application (apn02358) to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **additional intake of NTT course** of Two year duration with an annual intake of **50 (Fifty Only) students.**

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **M. A. Educational Institute, Packet H - 3, Sector - 18, Rohini, Delhi - 110042** for conducting **NTT Course** of Two year duration with an annual additional intake of 50 (Fifty Only) (Existing 50 + Additional 50 = 100) students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

ORDER

M. A. Educational institute, Pocket-H, Sector-18, Rohini, Delhi had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for starting NTT Course of two years duration in terms of Section 14(1) of the NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to M. A. Educational Institute, Pocket-H, Sector-18, Rohini, Delhi for NTT course of Two years duration w.e.f. 15th September 2004 with an annual intake of 50 (Fifty) students in the 1st year and the same for the IInd year subject to fulfillment of the following before commencement of the session :-

- Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / SCERT is to be completed before the commencement of the academic session.
- The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional committee.
- That the Reserve Fund for an amount equal to three months salary of the teachers & staff be created within one month from the date of issue of this order and maintained in the form of FDR in favor of the management/ institution, for a period of not less than sixty months (five years) in a Nationalized Bank.
- Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.

3. Recognition is subject to the condition that the affiliating body shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/State Govt /Affiliating Body.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
5. The institution shall submit to the Regional Committee a Self Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


