ORDER

WHEREAS Maharshi Valmiki College of Education, Shakarpur, Delhi-110092 had applied for grant of recognition for B.Ed. Course of one year duration under Section 14(a) of the NCTE Act, 1993 to the NRC, NCTE (Jaipur).

- AND WHEREAS the institution was granted recognition for B.Ed. course of one year duration from the academic session 2000-2001 with an annual intake of 120 students vide NRC, NCTE Order No.F-3/DH-02/B.Ed./2000/5937-44 dated 15.07.2000.
- 3. AND WHEREAS the Institution informed vide its letter dated 23.07.2003 that the college has been shifted from the premises of Bhal Parmanand Institute of Business Studies, Shakarpur to Geeta Colony. The matter was placed before the NRC in its 69th meeting held on 28-29 August, 2003 and as per decision of the Committee inspection of the institution at new building was conducted on 22.12.2003.
- 4. AND WHEREAS in its 77th meeting held on 7th April, 2004, the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, satisfied that the applicant institution does not fulfill the requirements and came to the conclusion that recognition to the said institution be withdrawn from the academic session 2004-2005 and accordingly recognition granted to the institution vide order. No.F-3/DH-02/B.Ed./2000/5937-44 dated 15.07.2000 was withdrawn vide order dated 13.4.2004.
- 5. AND WHEREAS the Institution i.e., Maharshi Valmiki College of Education preferred an appeal dated 7th May, 2004 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order and vide order No.89-77/2004/Appeal/36926 dated 23.6.2004 the Council reversed the order appealed against for conducting BED Course to Maharshi Valmiki College of Education, Geeta Colony, Delhi for an intake of 120 students only from the academic session 2004-2005.
- 6. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Maharshi Valmiki College of Education, Geeta Colony, Delhi 110 031 for conducting B.Ed. Course of one year duration from the academic session 2004-2005 with an annual intake of 120 students under the NCTE Norms and Regulations subject to fulfillment of the following:
 - (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be
 prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the
 State Government etc, wherever applicable.

A copy of the format is enclosed with the order.
- 9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure; —
 - Copy of the Application Form
 - Land and Building Particulars
 - Statt Profile
 - Recognition letter
 - Information for having fulfilled the norms & standards and other required conditions.
