- The institution shall ensure the fulfillment of the following:-
  - Selection of qualified staff through duty constituted selection committee as per the norms of NCTE / State Govt. / Affiliating University/ Body given effect before the commencement of the course.
  - The institution shall maintain the teaching staff strength of 1+5 for the proposed El.I. Course.
  - c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
  - d. The institution shall within one month of the recent of Recognition order, convert the Endowment Fund account into a loint Account in the form of FDR for a period of not less then 60 months ( Five years), in a Nationalized Bank only to be operated along with an official of the Regional Committee.
  - e. That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in faviour of the management Austitution.
  - Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like USC and State Government, elc.
  - The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered
  - The institution shall regularly update its website.
