## ORDER

District Institute of Education & Training, (DIET), Near Rani Tal, Nahan, Distt. - Sirmour, Himachal Pradesh - 173001 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of additional seats in J.B.T. Course of two Year duration in terms of section 15(1) of NCTE Act, 1993.

- 2. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to District Institute of Education & Training, (DIET). Near Rani Tal. Nahan, Distr. Sinnour, Himachal Pradesh 173001 for an additional intake of 80 (Eighty) seats thereby making the total annual intake of the institution to 200 (Two Hundred) i.e. 200 in the 1<sup>st</sup> year and the same for the 2<sup>st</sup> year in J.B.T. Course of two year duration with effect from the academic session 2004-2005 subject to fulfillment of the following before the commancement of the session:
  - a. Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt/UGC is to be completed before the commencement of the session.
  - b. The countersigned statement of all faculty members from the Director, SCERT should be submitted before the commencement of the academic session 2004-2005.
  - c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
  - d. Before starting the course the institution should seek prior permission of the competent authority for conducting the exoms and approval of the curriculum that they are going to adopt for the course.
  - a. Institution if starts the training programme without prior approval / permission of competent authority / exemining body regarding the curriculum they have adopted and conduct of examination for award of Diploma / Certificate the recognition of such institutions shall withdrawn.
  - Non-compliance of the above mentioned conditions shall cause action under section 17
    of NCTE Act, 1993
- 3. The Recognition is subject to the condition that the affiliating body shall enture that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / Affiliating body.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like USC and State Government, SCERT, etc.
