#### ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations. 2014 on 01.12.2014.

- AND WHEREAS, the recognition was granted by NRC to Minerva College of Education, VPO Baggi, Tehsil & District - Mandi, Himachal Pradesh for B.Ed. Course vide order No. NRC/NCTE/HP-190/157th Meeting/2010/20339-20345 dated 15.04,2010 with an annual intake of 100 seats.
- AND WHEREAS, the said institution has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- AND WHEREAS, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.
  - The institution shall create additional facilities that include (a) additional built-up-area, (b) additional (i) infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - The application-Institution for additional unit will be required to submit the required documents such as (ii) land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
  - The Regional Committees shall arrange for verification of documents, inspection of these premises and (iii) check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
  - In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the (iv) NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Minerva College of Education, VPO - Baggi, Tehsil & District - Mandi, Himachal Pradesh for conducting B.Ed, programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other 5. regulatory bodies like UGC. affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

- 7. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
  - (a) Sanctioned programmes along with annual intake in the institution.
  - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - (c) Name of faculty members who left of joined during the last quarter.
  - (d) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - (e) Fee charged from students.
  - (f) Available infrastructural facilities.
  - (g) Facilities added during the last quarter.
  - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
  - (i) The affidavit with enclosure submitted along with application.
  - (j) The institution shall be free to post additional relevant information, if is so desires.
  - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

ORDER

Whereas recognition was granted to the institute Minerva College of Education, VPO Baggi, Tehsil & Distt. – Mandi, Himachal Pradesh under section 14 of NCTE Act, 1993 for conducting B.Ed course with an intake of 100, vide order No. F.NRC/NCTE/F-3/HP-190/24590 dated 16<sup>th</sup> August, 2007.

And whereas on direction of NCTE HQtrs, New Delhi, the Northern Regional Committee in its  $140^{th}$  Meeting held on  $25^{th} - 26^{th}$  April, 2009 decided to inspect the institution before taking further action u/s 17 of the NCTE Act.

And whereas, the inspection of the institution was conducted on 01.07.2009.

And whereas, the matter was considered by the NRC in its 144<sup>th</sup> Meeting of NRC whereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

- The Classrooms are too small.
- Science lab does not exist.
- ET lab is too small.
- Not a single Faculty appointment is approved by the affiliating University.
- Fixed salary is being paid in cash.
- Some of the committee members are working in the college as Clerk / peon.
- FDRs of Rs. 5 lakh and Rs. 3 Lakh are with the Management.
- All laboratories are small and ill equipped.
- Ten Computers are not enough for 100 students.
- The Principal and Faculty rooms are too small.
- The number of titles in the library is not as per NCTE norms.
- Language learning facilities are not available.
- Girls and boys common rooms are too small.
- On the whole the total built up area is not as per NCTE norms for B.Ed.

And whereas the NRC directed that an opportunity be given to the institution to make a written representation within 21 days from the date of issue of the letter before withdrawal of recognition as per provisions contained under section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on 22.07.2009.

And Whereas the matter was again considered by the Northern Regional Committee in its 157<sup>th</sup> Meeting held on 22<sup>nd</sup> to 24<sup>th</sup> March, 2010 and having taken into consideration the reply dated 21.12.2009 submitted by the institution and all the relevant facts of the case, it was decided to withdrawn recognition for conducting **B.Ed** course from next academic session i.e. 2010-2011.

Now, therefore recognition to Minerva College of Education, VPO – Baggi, Tehsil & Distt. – Mandi, Himachal Pradesh for the B.ED. in terms of Section 17(1) of the NCTE Act, 1993, is hereby withdrawal from next academic session i.e. 2010-2011 on the following grounds:-

• The deficiencies communicated to the Institute through letter F.NO/ NRC/NCTE/ HP-190/ 144<sup>h</sup> Meeting/ 2009/6504 dt. 22 July 2009 still exist.

Affiliating Body/ State Govt. are advised not to admit / allot any student in **B.ED**. in the said institute. In accordance to the Section 17(4) of NCTE Act, 1993, the qualification in teacher education obtaining pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Central Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadhur Shah Zafar Marg, Near ITO, New Delhi-110002 against this order under Section 18 of the NCTE Act., 1993 within 60 days of the issue of this order. The guideline of appeal are enclosed herewith.
