ORDER

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the institution Shanti College of Education, Village – Kailash Nagar, Post – Nakroh, Tehsil – Amb, Dist. – Una – 177213, Himachal Pradesh was recognized by NRC vide its Order No. NRC/NCTE/F-7/HP-260/2011/10902-908 dated 14.07.2011 for M.Ed. course for 35 seats.
3. AND WHEREAS, the institution Shanti College of Education, Village – Kailash Nagar, Post – Nakroh, Tehsil – Amb, Dist. – Una – 177213, Himachal Pradesh has by affidavit consented to come under New Regulations and sought for one basic unit in M.Ed. which require additional facilities.
4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Shanti College of Education, Village – Kailash Nagar, Post – Nakroh, Tehsil – Amb, Dist. – Una – 177213, Himachal Pradesh for conducting M.Ed. programme of two years duration with an annual intake of 50 for one basic unit of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.



7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
- Sanctioned programmes along with annual intake in the institution.
 - Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - Name of faculty members who left of joined during the last quarter.
 - Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - Fee charged from students.
 - Available infrastructural facilities.
 - Facilities added during the last quarter.
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information, if it so desires.
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

ORDER

WHEREAS, in terms of section 15(1) of the NCTE Act, 1993 Shanti College of Education, Village- Kailash Nagar, Post- Nakroh, Tehsil- Amb, District- Una - 177213 Himachal Pradesh had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for M.Ed Course of one year duration with an annual intake of 35 (Thirty Five Only) students on 28.12.2007.

AND WHEREAS, the matter was considered by the NRC, in its 139th Meeting held from 10th to 12th April, 2009 and committee decided that the LOI for Inspection is to be issued. Accordingly, letter was issued to the institution on 15.05.2009 on following points:-

- The Land is to be registered in the name of Institution with in 90 days.

AND WHEREAS, the inspection of the institution was conducted under section 15 on 20.08.2009. The original file of the institution, VTR along with all other related documents, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time were considered by the committee in its 148th meeting held from 28th to 30th August, 2009 and the committee decided to refuse recognition. Accordingly, refusal order was issued to the institution on 31.08.2009.

AND WHEREAS, the above said Institution, thereafter preferred an appeal before the Council (NCTE, New Delhi) under section 18 of the NCTE Act, 1993 against the aforesaid order. The Council vide order dated 06.11.2009 rejected the appeal NRC's order dated 31.08.2009 was confirmed.

AND WHEREAS, the institute had filed a writ petition No. WP (C) 1320/2009 and CM No. 14394/2009 before the Hon'ble High Court of Delhi. The matter was again considered by the Council in the light of Court order passed by the Court in the said writ petition and the case was remanded back by the Council to NRC, with the direction to NRC for issuance letter of intent (LOI) prior to grant recognition under clause 7(9) of NCTE Regulation 2007.

AND WHEREAS, the said order was considered by the NRC, in its 166th meeting held on 09th September, 2010 and committee decided that the letter of intent prior to recognition be issued under clause 7(9) of NCTE Regulation 2009. Accordingly, letter of intent under clause 7(9) was issued to the institution on 14.09.2010.

AND WHEREAS, the reply was considered by the NRC, in its 169th meeting held on 12th & 13th October, 2010 and committee decided to issued show cause notice. Accordingly, show cause notice was issued to the institution on 22.10.2010.

AND WHEREAS, the reply of the institution dated 20.11.2010 w.r.t. the show cause notice dated 22.10.2010 has been considered by the NRC, in its 174th meeting held from 08th to 10th December, 2010 and hence institution be asked to submitted approval of the university to the faculty appointment. Accordingly, clarification letter was issued to the institution on 25.01.2011.

AND WHEREAS, the reply of the Institution dated 23.02.2011 with respect to NRC's letter dated 25.01.2011 has been considered by the NRC, in its 180th meeting held from March 23-26, 2011, March 31-April 1, 2011, and April 9-11, 2011 and committee decided to issue clarification on following grounds:-

- Experience Certificate in respect of Sri Chandra Kant Sharma's appointment as Associate Professor has not been submitted to establish that he possessed teaching experience of 3 years at M.Ed. Level. As such his appointment is not as per NCTE Norms.

AND WHEREAS, the reply dated 14.09.2010 conveying the details of appointment and faculty and approval of the University to these appointments has been considered by the NRC, in its 183rd (2nd Setting) held from 08th to 14th June, 2011 and committee decided that the formal recognition Under Clause 7(11) of the NCTE Regulations be issued for 35 seats of M.Ed. course from the academic session 2011-2012 be issued to the institution.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Shanti College of Education, Village- Kailash Nagar, Post- Nakroh, Tehsil- Amb, District- Una - 177213 Himachal Pradesh for conducting M.Ed. One year Course with an annual intake of 35 (Thirty Five Only) students from the academic session 2011-2012 under clause 7(11) of NCTE Regulations subject to the following conditions:

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated alongwith an officer of the Northern Regional Committee.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2009.

Further, the recognition/permission is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- Copy of the Application Form
- Land and Building Particulars
- Staff Profile
- Recognition letter
- Information for having fulfilled the norms & standard and other required conditions.

In case if the land is in the name of the Society, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee along with the new land document within the stipulated time.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made or issued, there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act 1993.
