**ORDER**

WHEREAS in terms of Section 15 (1) of the NCTE Act, **Kalpna Chawla College of Education, Chikanwas, 14 K.M. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Kalpna Chawla College of Education, Chikanwas, 14 K.M. Stone, Hisar- 125001, Haryana**, for conducting **B.Ed. course of one duration** with an annual intake of Existing **100+ Add 100 = 200 (Two Hundred Only)** students under clause 7(12) of Regulation dated 13-1-2006 subject to fulfilment of the following:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
