WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND, WHEREAS**, the recognition has been granted to the institutions mentioned in para 5 below for the course mentioned against their name.

3. **AND, WHEREAS,** the said institutions by affidavit have consented to come under New Regulations and have sought for the number of units in B.Ed./B.P.Ed./M.Ed. as mentioned in para 5 below against their name, which may require additional facilities.

4. **AND, WHEREAS,** it has been decided to permit the institution to have the desired number of units subject to fulfilling the following conditions:-

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The applicant Institution for additional unit will be required to submit the required documents, such as, land documents, Non Encumbrance Certificate (EC), Change of Land Use Certificate (CLU) and Building Plan (BP) in the specified proforma available on the website of the Regional Committee in proof of having provided the additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committee shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution has failed to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. This order shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case and in respect of Section 17/complaint cases etc. as decided by the Northern Regional Committee.

5. Now, therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to the following institutions for conducting the under-mentioned programme/<u>intake of two years duration</u> from the academic session 2015-2016 subject to fulfillment of the conditions before 31.10.2015 mentioned in para 4 above:-

10. Any false or incomplete information on the website of the institution shall render the institution liable for withdrawal of recognition.

11. If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there-under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 S.D. College of Education, VPO- Janaula Paraudi, Tehsil-Farukh Nagar, Distt- Gurgaon, Haryana (HR- 1318) has submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting B.Ed Course of One year duration with an annual intake of 100 (One Hundred

AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution on 29.05.2008 and 1. 06.10.208.

AND WHEREAS the matter was placed in 139th Meeting held on 10th to 12th April 2009. The Northern Regional 2. Committee after considering the application and reply submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, was satisfied that the applicant institution does not full fill the requirements and has decided to refuse recognition of the institution. Accordingly, Refusal order was issued vide order No. F.NRC/NCTE/F-7-3/HR-1318/2009/878-885 dated 23.04.2009.

AND WHEREAS the institution has preferred an appeal on 24.09.2009 against the refusal order of NRC dated 23.04.2009 3. to the Appellate Authority. The appeal of the institution was accepted and NRC's order dated 23.04.2009 was set aside by the appellate authority with direction to the NRC to issue letter of intent prior to grant of recognition under clause 7(9) of regulation 2007 vide order dated 18.11.2009. Accordingly, letter of intent was issued to the institution vide letter dated 04.12.2009.

AND WHEREAS the original file of the institution, reply of the institution submitted in compliance of letter of intent issued under clause 7(9) along with all other related documents, affidavits, Act of NCTE, 1993, Regulations and Guidelines of NCTE published from time to time, etc. were considered by the Northern Regional Committee in its 154th meeting held on 09th to 11th January 2010 and the Committee observed that:

- In case of Ms. Sapna the Father's name as given in affidavit is Shri Ram Munjal whereas in the certificates the name of the candidate is mentioned as Ms. Sapna Sehgal and Father's name as Shri. L.D.Sehgal.
- Dr. Manish Saxena is not qualified as per NCTE norms.

The appeal of the institution was accepted and NRC's order dated 24.02.2010 was reversed with a direction to the NRC to issue formal recognition order under clause 7(11) of NCTE regulations vide order dated 10.03.2010.

(a) The admission of students shall be made only after affiliation by the examining body before the commencement of th academic session and the admission of students shall be completed well before the cut of date prescribed by the examining body fo the academic session 2009-2010 failing which the recognition will be effective from the academic session 2010-2011 only.

(b) Formal orders for recognition/permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the university /Affiliating body.

9. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along with an officer of the Northern Regional Committee.

10. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

11. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10-12-2007.

12. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

13. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

14. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
