ORDER

WHEREAS **Lord Krishna College of Education, VPO- Siwani Bolan, Dist. Hisar, Haryana** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting **B.Ed Course** of **One year** duration under Section 14(1) of NCTE Act 1993 on **21.7.2008**.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution on 7.9.08. In its 137th meeting held on 28th Feb - 01st March 2009 the Northern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, was satisfied that the applicant institution does not fulfill the requirements and issued a notice on 8.3.2009 to the applicant institution under provision to Section 14(3)(b) of the NCTE Act 1993 thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

3. AND WHEREAS the applicant institution has submitted representation to the Northern Regional Committee, NCTE on 8.4.2009. The said representation of the institution as well as other documents and materials submitted by the institution alongwith VTR videography were again duly considered by the NRC in its 130th meeting held on 10-12th April 2009 the Committed had decided that recognition to the said institution be refused. Accordingly, a Refusal order was issued on 23.4.2009.

4. AND WHEREAS the applicant institution had preferred an appeal on 22.6.2009 against the Refusal order of NRC dated **23.4.2009** to the appellate authority. The appeal of the institution has been rejected and NRC's order dated **23.04.2009** was confirmed by the appellate authority vide their order No. 89-475/2009 Appeal/99987 dated **07.08.2009**.

5. AND WHEREAS the applicant institution has filed a W.P.(C) No. 11068/2009 in the Hon'ble High Court of Delhi. The Court has set aside the appellate authority's order dated 07.8.2009 and remanded the matter to the Council for consideration afresh. The Council as per the directions of the Hon'ble High Court, has reconsidered the matter on 4.9.09 and remanded to the NRC for conducting an inspection and taking an appropriate decision thereafter vide their order dated 4.9.09.

6. AND WHEREAS applicant institution has filed another Writ Petition (Civil) No. 12154 in the Hon'ble High Court of Delhi. The Hon'ble High Court has set aside and quashed the order dated 4.9.2009 passed by the Council and directed to grant recognition to the petitioner for the B.Ed. course forthwith vide their order dated 22.10.2009.

7. AND WHEREAS the matter was placed in 152nd meeting of Northern Regional Committee held on 23-25th November 2009. The Committee has decided to implement the orders of Hon'ble High Court of Delhi.

8. AND THEREFFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition/permission to **Lord Krishna College of Education, VPO- Siwani Bolan, Dist. Hisar, Haryana** for conducting B.Ed. Course of one year duration with an annual intake of 100 (one hundred only) students from the academic session 2009-2010 under clause 7(11) of NCTE Regulations, 2007 notified on 10.12.2007 subject to fulfillment of the following conditions as per the clarification from NCTE HQtrs letter No. file No. 48-3(1)/2008/NCTE/(N&S) dated 01.10.2009.

- I. **The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of the students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010, failing which the recognition will be effective from the academic session 2010-2011 only.**
- II. **Formal orders for recognition / permission will operate for 2009-2010 only if the requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating body.**

9. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and Reserve fund account into a joint account to be operated along with an officer of the Northern Regional Committee.

10. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

11. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulation, 2007 notified on 10.12.2007.

12. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc, wherever applicable.

13. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the format is enclosed with the order.

14. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.

15. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

16. In case if the land is in the name of the Society, you must transfer the land within six months in the name of institution failing which action shall be initiated to withdraw the recognition. It shall be essential on part of the institution concerned to get the needful done in this regard and intimate the respective Regional Committee alongwith the new land documents within stipulated time.
