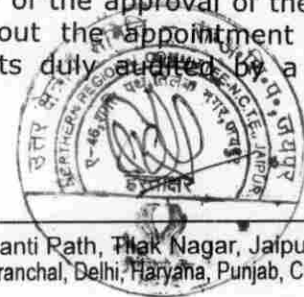

Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to **Laxmi College of Education, Kasan Road, Village + Post - Maneshar , Gurgaon, (Haryana)** to conduct **B.Ed. Course** of One-year duration **w.e.f. the session 2006-2007** with an annual intake of **100 (One Hundred Only) (One Unit)**, subject to appointment of staff as per Regulations and ratification by the University at the following address :-

4. The institution shall ensure the fulfillment of the following :-

- The institution shall maintain the teaching staff strength of **1+7 for the B.Ed. Course.**
- The institution shall note that with regard to NET/SLET requirement, the relaxation is allowed only upto the year 2009-2010 as per NCTE Regulation dt. 21.07.2006.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management/institution.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- The institution shall regularly update its website.
