**RECOGNITION ORDER**

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 **Sangha Education Society, P.No.- Shop No.- 46, Street/Road- Anaj Mandi, Village/Town- Sardulgarh, Tehsil/Taluka- Sardulgarh, Post Office- Sardulgarh, Town/City- Sardulgarh, Distt.- Mansa- 151507, Punjab.** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. **Sangha College of Education, P.No.- 15/1,11/1,10/2, Street No.- Delhi Road, Village- Sangha, P.O. – Sardulgarh, Tehsil – Sardulgarh, Distt.- Mansa-151507, Punjab.** for D.El.Ed. Course of two year duration for an annual intake of 50 (Fifty Only) students on 05.10.2010.

2. AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also keeping in view of the **reply of letter of intent under clause 7(9) dated 10.07.2012**, the Northern Regional Committee in its 201<sup>st</sup> meeting held from 12<sup>th</sup> July to 15<sup>th</sup> July, 2012 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to **Sangha College of Education, P.No.- 15/1,11/1,10/2, Street No.- Delhi Road, Village- Sangha, P.O. – Sardulgarh, Tehsil – Sardulgarh, Distt.- Mansa-151507, Punjab** for conducting **D.El.Ed. Course** of Elementary (level) of two year duration with an annual intake of **50 (Fifty Only)** from the **academic session 2012-13** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfilment of the following conditions:-

- (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- (iii) The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.
