RECOGNITION ORDER

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Sangha Education Society, P.No.- Shop No.-46, Street/Road- Anaj Mandi, Village/Town- Sardulgarh, Tehsil/Taluka- Sardulgarh, Post Office- Sardulgarh, Town/City- Sardulgarh, Distt.- Mansa- 151507, Punjab. had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Sangha College of Education, P.No.- 15/1,11/1,10/2, Street No.- Delhi Road, Village- Sangha, P.O. - Sardulgarh, Tehsil - Sardulgarh, Distt.- Mansa-151507, Punjab. for D.El.Ed. Course of two year duration for an annual intake of 50 (Fifty Only) students on 05.10.2010.

AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also keeping in view of the **reply of letter of intent under clause 7(9) dated 10.07.2012**, the Northern Regional Committee in its 201st meeting held from 12th July to 15th July, 2012 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.
- 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Sangha College of Education, P.No.- 15/1,11/1,10/2, Street No.- Delhi Road, Village- Sangha, P.O. Sardulgarh, Tehsil Sardulgarh, Distt.- Mansa-151507, Punjab for conducting D.El.Ed. Course of Elementary (level) of two year duration with an annual intake of 50 (Fifty Only) from the academic session 2012-13 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfilment of the following conditions:-
 - (i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
