RECOGNITION ORDER

WHEREAS in terms of section 15(1) of the NCTE Act, 1993, Ocean, Plot no. 649/2, 654/3, 755, Street/Road – NH-21, Village/Town/City – Bagru Rait, P.O. Rait, Tehsil/taluka – Shahpur, Town/City – Shahpur, District – Kangra -176208, Himachal Pradesh has submitted an application (Code No. NRCAPP-1518) to the Northern Regional Committee of NCTE for grant of recognition for conducting M.Ed. - 3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Dronacharya College of Education, Plot No. 649/2, 654/3, 755, Village Rait, P.O. -Rait, Town/City Kangra, Tehsil/Taluka Shahpur, District Kangra-176208, Himachal Pradesh. for conduction M.Ed. Course of Secondary level of one year duration with an annual intake of 35 (Thirty five only) from the academic session 2013-14 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-
- i. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- ii. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- iii. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

In case if the land is in the name of the Society/trust, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. - 8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
