- NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to M R Bharati College of Education, Plot/Khasra No. 53/6, Village-Mundka, P.O.-Mundka, Tehsil-Nangloi, District-West Delhi, Delhi for conduction of D.El.Ed. course of Elementary level of two year duration with an annual intake of 50 (Fifty only) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-
  - The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
  - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
  - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

  - IV. Recognition letter
  - V. Information for having fulfilled the norms & standard and other required conditions.
- In case if the land is in the name of the Society/trust, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on
