- NOW, THEREFORE, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Jagriti Teachers Training College, Plot No. 27/52, Village Deodhar, P.O. -Talyahar, Town/City Mandi, Tehsil/Taluka –Sadar, District Mandi-175001, Himachal Pradesh, for conduction D.El.Ed. Course of Two year duration with an annual intake of 50 (Fifty only) from the academic session 2013-14 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-
 - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- ii. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
