ORDER

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. **AND WHEREAS**, the institution Mata Sahib Kaur Khalsa Girls College of Education, Plot No. - 150/1, Street/Road – Near Railway Crossing No. 24, Village/Town/City – Dhamo Majra, Tehsil/Taluka – Patiala, Town/City- Patiala, Distt.- Patiala – 147001, Punjab was recognized by NRC vide its Order No. NRC/NCTE/NRCAPP-727/204th Meeting/31566-572 Dated 31.08.2012 for B.Ed. course for 200 seats.

3. **AND WHEREAS**, the institution Mata Sahib Kaur Khalsa Girls College of Education, Plot No. - 150/1, Street/Road – Near Railway Crossing No. 24, Village/Town/City – Dhamo Majra, Tehsil/Taluka – Patiala, Town/City- Patiala, Distt.- Patiala – 147001, Punjab has by affidavit consented to come under New Regulations and sought for four basic units in B.Ed., which require additional facilities.


4. **AND WHEREAS**, it has been decided to permit the institution to have four basic units of 50 students each subject to the institution fulfilling following conditions namely.

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. **Now therefore**, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Mata Sahib Kaur Khalsa Girls College of Education, Plot No. -150/1, Street/Road – Near Railway Crossing No. 24, Village/Town/City – Dhamo Majra, Tehsil/Taluka – Patiala, Town/City- Patiala, Distt.- Patiala – 147001, Punjab for conducting B.Ed. programme of two years duration with an annual intake of 200 for four basic units of 50 students each from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
- Sanctioned programmes along with annual intake in the institution.
 - Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - Name of faculty members who left or joined during the last quarter.
 - Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - Fee charged from students.
 - Available infrastructural facilities.
 - Facilities added during the last quarter.
 - Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - The affidavit with enclosure submitted along with application.
 - The institution shall be free to post additional relevant information, if it so desires.
 - Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

RECOGNITION ORDER

WHEREAS in terms of section 14(1) of the NCTE Act, 1993, Mata Sahib Kaur Khalsa Girls College of Education, Plot No.-150/1, Street/Road-Near Railway Crossing No. 24, Village/Town/City-Dhamo Majra, Tehsil/Taluka-Patiala, Town/City-Patiala, Distt.-Patiala-147001, Punjab has submitted an application (Code No. NRCAPP-727) to the Northern Regional Committee of NCTE for grant of recognition for conducting Additional intake in Existing B.Ed. Course on 08.10.2010 in the name of Mata Sahib Kaur Khalsa Girls College of Education, Plot No.-150/1, Village-Dhamo Majra, Tehsil/Taluka-Patiala, Town/City- Patiala, Distt.-Patiala-147001, Punjab.

2. AND WHEREAS on scrutiny/perusal of veracity of the facts & figures as per the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography the Northern Regional Committee in its 204th meeting held on 27th to 29th August, 2012 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.Ed. programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Mata Sahib Kaur Khalsa Girls College of Education, Plot No.-150/1, Village-Dhamo Majra, Tehsil/Taluka-Patiala, Town/City- Patiala, Distt.-Patiala-147001, Punjab for conduction Additional intake in Existing B.Ed. Course of Secondary level of one year duration with an annual intake of 100+100=200 (Two Hundred only) seats from the academic session 2012-13 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:-

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-


- I. Copy of the Application Form
- II. Land and Building Particulars
- III. Staff Profile
- IV. Recognition letter
- V. Information for having fulfilled the norms & standard and other required conditions.

7. In case if the land is in the name of the Society/trust, you must transfer the land within six month in the name of the institution failing to which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

9. Further, if the institution is not satisfied by this order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, I Bahadur Shah Zafar Marg, Near ITO, New Delhi-110002 under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.

ORDER

Mata Sahib Kaur Khalsa Girls' College of Education, Dhamomajra, Patiala – 147001, Punjab submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of B.Ed. course of one Year duration in terms of section 14(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Mata Sahib Kaur Khalsa Girls' College of Education, Dhamomajra, Patiala – 147001, Punjab** for **B.Ed. Course** with an annual intake of **100 seats (One Hundred), w.e.f. 28th June, 2005** subject to compliance of the following conditions before commencement of the academic session.

- Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Govt./UGC, is to be completed, before the commencement of the session.
- The countersigned statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session.
- The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.

3. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.


