ORDER

In terms of Section 14(1) of the NCTE Act, 1993 **Vishveshwarya Institute of Engineering & Technology, 23 Km. from Ghaziabad on Ghaziabad Bulandshahr G.T.Road, Post Bag.1, P.O. Dadri, G.B.Nagar, Uttar Pradesh - 203207** had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting **B.Ed. of One year** from the academic session **2002-2003** with an annual intake of **100 (One Hundred)** students.
