ORDER

Abdul Aziz Ansaree Degree College, Majdecha, Shahganj, Jaunpur, Uttar Pradesh had applied to Northern Regional Committee, National Council for Teacher Education for seeking recognition of the B.Ed. course from the academic session 2002-2003 vide letter No. 106/2001 dated 20.12.2001 received on 26.12.2001.

2. The institution was inspected on 10.08.2002 by an Expert Committee constituted by this office. The Inspection Report of the Expert Committee, original file of the institution, copy of the NCTE Act, 1993, copy of the Norms and Standards and other relating documents were placed before the NRC, NCTE in its 51st meeting held on 03.09.2002.

3. After careful perusal of the file, Inspection Report and other related documents, the Committee decided that the institution, in light of the provisions contained under Section 14(3)(b) of NCTE Act, 1993, be given an opportunity for making the written representation within one month from the date of issue of the letter of the following deficiencies noted in the case.

- Non availability of equipments in Social Science Lab;
- Non availability of Journals on teacher education.
- Non availability of Endowment Fund.
- Non availability of Reserve Fund.

4. As per the decision of NRC letter No. NRC/NCTE/F-3/UP-571/2002/7560 dated 10.09.2002 was issued by Northern Regional Committee, National Council for Teacher Education to the institution.

5. The institution submitted a written representation vide letter No. 186/2002 dated 25.09.2002. The representation of the institution was placed before the NRC in its 54th meeting, to verify the compliance of the deficiencies notified to the institution as mentioned in para 3 above. After careful perusal of the reply and all related documents, the NRC decided second inspection of the concerned institution.
