ORDER

In terms of Section 14(1) of the NCT Act, 1993 Shri Megh Singh Degree College, Abidgarh, Tarrakpur, Agra, Uttar Pradesh – 282006 had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for starting B.Ed. Course of One year duration from the academic session 2002-2003 with an annual intake of 100 (One Hundred) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- (i) The institution has acquired the land for setting up the teacher education institution.
- (ii) The institution has constructed the building for conducting the course on the above mentioned land.
- (iii) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs. 2,50,000.00 (Rupees Two Lacs Fifty Thousand Only).
- (iv) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Shri Megh Singh Degree College, Abidgarh, Tarrakpur, Agra, Uttar Pradesh – 282006 for B.Ed. course of One year duration from the academic session 2002-2003 with an annual intake of 100 (One Hundred) students Subject to fulfilment of the following :-

- (a) That the institution will ensure that Principal / Head and at least Seven faculty members are in position for an intake of 100 (One Hundred) students before commencement of the course and a report of this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
