### ORDER

**Viragha Avanti Bai Mahila Mahavidyalya , Uddaitapur , Shikohabad Road, Etah-207001 , U.P.** had applied to Northern Regional Committee, National Council for Teacher Education for seeking recognition of the **B.Ed. course** from the academic session 2002-2003 vide letter No. nil dated **21.12.2001 and received on 27.12.2001.**

2. The institution was inspected on **24.08.2002** by an Expert Committee constituted by this office. The Inspection Report of the Expert Committee, original file of the institution, copy of the NCTE Act, 1993, copy of the Norms and Standards and other relating documents were placed before the NRC in its **51<sup>st</sup> meeting held on 3.9.2002.**

3. After careful perusal of the file, Inspection Report and other related documents, the Committee decided that the institution, in light of the provisions contained under Section 14(3)(b) of NCTE Act, 1993, be given an opportunity for making the written representation within one month from the date of issue of the letter of the following deficiencies noted in the case:

- (a) **Non availability of equipment in method laboratory.**
- (b) **Non availability of text books and journals.**
- (c) **Non availability of Endowment Fund.**
- (d) **Non availability of Reserve Fund.**

4. As per the decision of NRC letter No. **NRC/NCTE/F-3/UP-567/7576** dated **10/11.9.2002** was issued by Northern Regional Committee, National Council for Teacher Education to the institution.

5. The institution submitted a written representation vide letter No. nil dated **24.09.2002 received NRC on 30.9.2002.** The representation of the institution was placed before the NRC in its **54<sup>th</sup> meeting** to verify the compliance of the deficiencies notified to the institution as mentioned in para 3 above. After careful perusal of the reply and all related documents, the NRC decided second inspection of the concerned institution.
