## ORDER

**K.K. Degree College, Site - C, UPSIDC, C-7,8 & 9, Sikandra, Agra, U.P.** had applied to Northern Regional Committee, National Council for Teacher Education for seeking recognition of the **B.Ed. course** from the academic session 2002-2003 vide letter No. **MPET/ CORRESP/C-01/01-02 dated 28.12.2001** received on 28.12.2001.

2. The institution was inspected on 28.05.2002 by an Expert Committee constituted by this office. The Inspection Report of the Expert Committee, original file of the institution, copy of the NCTE Act, 1993, copy of the Norms and Standards and other relating documents were placed before the NRC in its 48<sup>th</sup> meeting held on 29.6.2002.

3. After careful perusal of the file, Inspection Report and other related documents, the Committee decided that the institution, in light of the provisions contained under Section 14(3)(b) of NCTE Act, 1993, be given an opportunity for making the written representation within one month from the date of issue of the letter of the following deficiencies noted in the case.

- (a) The building in which the institute proposes to run the B.Ed. programme is completely in a commercial complex which has been divided into various rooms, and among them, some classes are not plastered.
- (b) Public facilities are not appropriate.

4. As per the decision of NRC letter No. **NRC/NCTE/F-3/UP-617/6735-3736 dated 22.07.2002** was issued by Northern Regional Committee, National Council for Teacher Education to the institution.

5. The institution submitted a written representation vide letter No. **MPET/KKS/2002/52/ dated 29.07.2002**. The representation of the institution was placed before the NRC in its 54<sup>th</sup> meeting to verify the compliance of the deficiencies notified to the institution as mentioned in para 3 above. After careful perusal of the reply and all related documents, the NRC decided second inspection of the concerned institution.
