ORDER

Maq Khandwari Degree College, Chahania, Chandauli, Uttar Pradesh – 23109 had applied to Northern Regional Committee, National Council for Teacher Education for seeking recognition to the B.Ed. course from the academic session 2002-2003 vide letter No.Nil dated Nil received on 31.12.2001.

2. The institution was inspected on 04 September, 2002 by an Expert Committee constituted by this office. The Inspection Report of the Expert Committee, original file of the institution, copy of the NCTE Act, 1993, copy of the Norms and Standards and other relating documents were placed before the NRC, NCTE in its 53rd Meeting held on 25 September, 2002.

3. After careful perusal of the file, Inspection Report and other related documents, the Committee decided that the institution, in light of the provisions contained under Section 14(3)(b) of NCTE Act, 1993, be given an opportunity for making the written representation within one month from the date of issue of the letter of the following deficiencies noted in the case:

- (a) Non completion of building for B.Ed. course.
- (b) Non existence of Education Technology Lab.
- (c) Non existence of Method Labs.
- (d) Non existence of Psychology Labs.
- (e) Non availability of Endowment Fund.
- (f) Non availability of Reserve Fund.
- (g) Non availability of equipments and teaching aids for Method Labs.
- (h) Non availability of equipments for Psychology Lab.
- (j) Non availability of equipments for Education Technology Lab.

4. As per the decision of NRC letter No. NRC/NCTE/F-3/UP-633/2002/7735, dated 05/07 October, 2002 was issued by Northern Regional Committee, National Council for Teacher Education to the institution giving opportunity to make written representation to NRC within one month from the date of issue of letter before refusing recognition of the proposed course on account of deficiencies noted above.
