### **ORDER**

In terms of Section 15(1) of the NCTE Act, 1993 **Sudhakar Mahila Mahavidyalaya, S-9/92-93, Khajuri, Nai Basti, Pandey Pur, Varanasi, Uttar Pradesh - 221002** had submitted an application to the Northern Regional Committee of National Council For Teacher Education for grant of recognition for **additional 120 (One Hundred Twenty) seats in B.Ed. course of one year duration** from the academic session **2002-2003**.

2. Considering the documents and Order of the Hon'ble High Court dt. 05.09.2002, the Northern Regional Committee in its Meeting held on 13<sup>th</sup> February, 2003, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, decided to grant recognition to **Sudhakar Mahila Mahavidyalaya, S-9/92-93, Khajuri, Nai Basti, Pandey Pur, Varanasi, Uttar Pradesh - 221002** for **increase in intake from 60 (Sixty) to 100 (One Hundred) seats in B.Ed. course of one year duration** from the academic session **2002-2003** subject to fulfillment of the following :-

- (a) That the institution will ensure that Principal / Head and at least seven faculty members are in position for an intake of **100 (One Hundred) students** before commencement of the course and a report of this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- (b) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR for a period of not less than SIXTY MONTHS (Five years) in a Nationalized Bank only (and not any other certificate) to be operated along with an official of the Regional Committee.
