ORDER

Vivekanand College of Education, Dhuara Palan, Gowndra Road, Aligarh - 202001, Uttar Pradesh had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for B.Ed. course at 1st Year iteration from 01-07-2003 to 30-06-2004 with an annual intake of 100 (One Hundred) students in the light of NCTE Act, 1993.

After scrutiny of the application submitted by the institution, the documents attached therewith and the representations received from the visiting team, the Committee has issued the following:

- The institution has acquired the land for setting up the teacher education institution.
- The institution has constructed the building for conducting the course on the above mentioned land.
- The institution has created an Endowment Fund of Rs. 1,00,000/- (Rupees One Lakh Only) and a Reserve Fund of Rs. 3,50,000/- (Rupees Three Lakh Five Thousand Only).
- The institution has initiated the process for recruitment of 100 (one hundred) students and teachers for the said course.

Therefore, in exercise of the powers vested under Section 14(2) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Vivekanand College of Education, Dhuara Palan, Gowndra Road, Aligarh - 202001, Uttar Pradesh for an intake of 100 seats (One hundred) units in B.Ed. course of one year duration with effect from the academic session 2003-2004.

Subject to fulfillment of the following before the commencement of the course:

- Appointment of the faculty members duly qualified and statutorily per the norms NCTE/State Govt./UGC can be completed before the commencement of the session.
- The countersigned statement of all faculty members from the Register of the concerned University should be submitted before the commencement of the academic session 2004.
- The institution shall adhere to all the other Regulations mentioned in framed by NCTE from time to time.
- The institution shall within ONE MONTH of the receipt of this order merge its Endowment Fund account into a joint account in the name of the concerned institution.
