ORDER

In terms of Section 14(1) of the NCTE Act, 1993, **R.K.Gupta Memorial Institute of Technology & Management, 123, U.P.S.I.D.C. Road, Sikandra, Agra, Uttar Pradesh-202007** had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for **40 (Forty) additional seats in B.Ed. course of one year duration.**

On scrutiny of the application submitted by the institution, the documents attached therewith and the report received from the visiting team, the Committee has worded the following:-

- (a) The institution has supplied the land for setting up the teacher education institution.
- (b) The institution has constructed the building for conducting the course on the above mentioned land.
- (c) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs.3,00,000.00 (Rupees Three Lacs Only).
- (d) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

Now, therefore, in exercise of the powers vested under Section 14(1) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **R.K.Gupta Memorial Institute of Technology & Management, 123, U.P.S.I.D.C. Road, Sikandra, Agra, Uttar Pradesh-202007** for an additional intake of **40 (Forty) seats from existing 60 to 100 (one hundred) seats in B.Ed. course of one year duration from the academic session 2003-2004** Subject to fulfillment of the following before commencement of the session:-

- (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE / State Govt. / UGC is to be completed before the commencement of the session.
- (b) The committed statement of all faculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2003-2004.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an official of the Regional committee.
- (e) That the Reserve Fund for an amount equal to three months salary of the faculty shall be maintained in the form of FDR in favour of the concerned institution for a period of not less than sixty months (five years) in a Nationalized Bank.
