ORDER

Smt. Draupadi Devi Tripathi Degree College, Rudrapur, Post Office- Khajani, Distt-Gorakhpur, (UP) 273-212 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for <u>B.Ed.</u> course of one Year duration in terms of section 14(1) of NCTE Act. 1993.

- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grant recognition to Smt. Draupadi Devi Tripathi Degree College, Rudrapur, Post Office- Khajani, Distt- Gorakhpur, (UP) 273-212 for an annual intake of 100 seats (One Hundred only) in B.Ed. course of One year duration with affect from the academic session 2004-2005 subject to fulfillment of the following before the commencement of the session.
- (a) Appointment of the faculty members duly qualified and staff as per the norms of NCTE/ State Gavt/UGC is to be completed before the commencement of the session.
- (b) The countersigned statement of all toculty members from the Registrar of the concerned University should be submitted before the commencement of the academic session 2004-2005.
- (c) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (d) The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five years) in a Nationalized Bank only to be operated along with an afficial of the Regional Committee.
- (e) That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- (f) Non-compliance of the above mentioned conditions shall cause action under section 17 (1) of NCTE Act, 1993.
- The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NETE / USC / Affiliating University.
