ORDER

WHEREAS, the institution, namely Shri Thakurji Maharaj Mahavidhaylaya, Safipur (Unnao), U.P. has made an application, vide covering letter dated 30.12.2003, under section 14(1) NCTE Act, 1993, read with the NCTE Regulations, 2002 for recognition to start B.Ed. course with an annual intake of 100 seats (One Unit) from academic year 2004-2005 under signatures of Smt. Shanti Devi as Manager of the institution. Sworn Affidavit verifying the contents of the application form and documents attached therewith which is affested by Notary is also submitted by Smt. Shanti Devi.

As required by the NCTE Regulations, 2002 the institution also submitted original Fixed Deposit Receipts (Deposit Centificate) No. 020137 dated 27.08.2001 for Rs. 05 Lacs, issued by Avadh Gramin Bank, Branch - Purwaia towards Endowment Fund, which an scrintiny and verification was confirmed to have been altered from Rs. 5,000/- to Rs. 5,00,000/-.

AND WHEREAS, in reply to notice under section 14(3)(b) of NCTE Act. 1993 dated 10th August, 2004 the above Manager of the institution, while admitting alteration in FDR, has tried to put the blame of committing misconduct on the Office Superintendent of the college with further request to close the file and return the original FDR and the subsequent FDR submitted by the institution. However, in subsequent letter request has been made by her to consider application for recognition to start B.Ed. course.

AND WHEREAS, the entire matter was considered by NRC in it's 88th meeting and on coreful perusal of the original file of the institution, the provisions of the Act. Rules and Regulations published from time to time, as wait as the replies of the institution and being satisfied of the forgery having been committed, decided to concel/reject the above application of the institution and militate criminal proceedings by lodging First Information Report

AND THEREFORE, the above application of Shri Thukunji Maharaj Maharahalaya, Safipur (Unnav), D.P. for recognition to start B.Ed. course stands rejected accordingly.
