- (d) The institution shall within one month of the receipt of Recognition order, convent the Endowment Fund account into a Joint Account in the form of FDS for a period of sixt less than 60 months (Five years) in a Nationalized Bank only to be operated along with an official of the Regional Committee.
- (6) That the Reserve Fond for an amount equal to three months enlarged the Teachers & Start he created within one month from the date of issue of this order and maintained in the form of FDR in favour of the inanagement/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- (f) Non-compliance of the above mentioned conditions shall course action under section 17 (1) of NCTE Act, 1993.
- 3. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appainted required number of faculty members (including. Principal / Head at Department), as per the norths of the NCTE / UGC / Affiliating University.

4 Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like USC and State Government, etc.
